The Government of Tamil Nadu having been satisfied that the lands specified in the Schedule below are acquired under Chennai Peripheral Ring Road Project for Highways Department, for the purpose of formation of road connectivity from Ennore Port to Mahabalipuram (from 124/672 Km. to 126/546 Km.) in Survey No.1/1A Part etc., in No.95, Karanai Village, Tiruporur Taluk, Chengalpattu District and it having already been decided that the entire amount of compensation to be awarded for the lands to be paid out of the funds controlled and managed by the Highways Department and after considering the cause shown by the owner or other persons having interest on such lands, as the case may be, do hereby publish the following notice under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act, 34 of 2002) read with the Tamil Nadu Land Acquisition Laws (Revival of Operation, Amendment and Validation) Act, 2019.

Mtrs. of lands are going to be acquired in No.95, Karanai Village, Tiruporur Taluk, Chengalpattu District to the same a little more or less needed for the purpose of formation of road connectivity from Ennore Port to Mahabalipuram (from 124/672 Km. to 126/546 Km.) as part of Chennai Peripheral Ring Road Project, Highways Department.
