The Government of Tamil Nadu having been satisfied that the lands specified in the schedule below are acquired under Chennai–Kanniyakumari Industrial Corridor Project for Highways purpose to wit for Strengthening and widening of SH-79, Tiruchengode-Erode Road from KM 93/700 to KM 94/190 at 16. Pallipalayam (Part-III) Village in Kumarapalayam Taluk, Namakkal District, and it having already been decided that the entire amount of compensation to be awarded for the lands to be paid out of the funds controlled and managed by the Divisional Engineer (H), Salem (CKICP), Tamil Nadu after having considering the cause shown by the owner or other persons having interest on such lands as the case may be do hereby publish the following notice is issued under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (TN Act 34 of 2002).
