The Government of Tamil Nadu having been satisfied that the lands specified in the Schedule below to be acquired for Highways purposes to wit "Reconstruction of ROB at km 314/10 of Chennai - Trichy - Dindigul Road (Old NH 45 Near Thiruvanaikoil) in lieu of existing old bridge No. 380A at Railway km 329/8-9 between Tiruchirappalli and Srirangam Railway Stations" at Jembukeswaram & Thimmarayasamuthiram Villages, in Srirangam Taluk of Tiruchirappalli District and it having already been decided that the amount of compensation to be awarded for the lands are to be paid out of the funds controlled or managed by the Special District Revenue Officer (L.A & M), Tiruchirappalli.
