REMOVAL OF VICE-CHAIRMAN, VEDASANDUR PANCHAYAT UNION COUNCIL, DINDIGUL DISTRICT
UNDER THE TAMIL NADU PANCHAYATS ACT, 1994.

WHEREAS, a written notice of the intention to make a motion expressing want of confidence in Tmt.S.Chandra, Vice-Chairman, Vedasandur Panchayat Union Council, Dindigul district, signed by twelve members, out of the sanctioned strength of fifteen members of the said Council, together with a copy of the motion proposed to be made and a written statement of charges against the said Vice-Chairman have been delivered to the Revenue Divisional Officer, Palani, Dindigul district in person by twelve members as per sub-section (2) of section 212 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994);

AND WHEREAS, the Revenue Divisional Officer, Palani, Dindigul district caused a copy of the statement of charges along with a copy of the notice of motion to be delivered, to the said Vice-Chairman Tmt.S.Chandra and she has not submitted her reply to the charges;

AND WHEREAS, a motion expressing want of confidence in Tmt.S.Chandra, Vice-Chairman, Vedasandur Panchayat Union Council, Dindigul district had been carried with a support of twelve members out of the sanctioned strength of fifteen members of the said Panchayat Union Council in the meeting convened by the Revenue Divisional Officer, Palani, Dindigul district on the 16th November 2022 after following the procedures specified in the said section 212 and forwarded the same to Government;

NOW THEREFORE, in exercise of the powers conferred by sub-section (13) of section 212 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994), the Governor of Tamil Nadu, hereby removes Tmt.S.Chandra, Vice-Chairman, Vedasandur Panchayat Union Council, Dindigul district from the office of the Vice-Chairman of the said Panchayat Union Council with immediate effect.
