Government of Tamil Nadu hereby notifies the sale of Tamil Nadu Government Stock (Securities) of **10-year** tenure for an aggregate amount of **Rs.2000 crore** (Nominal). The sale will be subject to the terms and conditions spelt out in this notification (called Specific Notification) as also the terms and conditions specified in the **General Notification No.404(L)/W&M-II/2019, dated 13th March 2019** of Government of Tamil Nadu.

#### **Object of the Loan:**

- (i) To Finance Part of Capital expenditure of Plan Schemes and other Development Schemes under execution.
- (ii) Consent of Central Government has been obtained to the floatation of this loan as required by Article 293(3) of the Constitution of India.
