NOTICE UNDER SECTION 15(1) OF TAMIL NADU HIGHWAYS ACT, 2001 READ WITH THE TAMIL NADU LAND ACQUISITION LAWS (REVIVAL OF OPERATION, AMENDMENT AND VALIDATION) ACT, 2019.

The Government of Tamil Nadu having been satisfied that the lands specified in the Schedule below have to be acquired for the purpose of Construction of Storm Water drain and Widening and Strengthening of Poonamallee – Kundrathur – Pallavaram Road from 2 lane to 6 lane, Essa Pallavaram Village, Pallavaram Taluk, Chengalpattu District and it have already been decided that the entire amount of Compensation to be awarded for the lands is to be paid out of the funds controlled or managed by the Divisional Engineer (Highways), Construction and Maintenance, Chennai City Roads Division, Chennai-600 015 and having considered the cause shown by the owners or other persons having interest in the said lands ,as the case may do hereby publish the following notice under sub-section (1) of Section 15 of Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34/2002).

Under sub-section (1) of Section 15 of the Tamil Nadu Highways Act 2001, (Tamil Nadu Act 34 of 2002), the Governor of Tamil Nadu hereby acquires the lands specified in the Schedule below measuring an extent of 988 Sq.Mtrs., required for Highways purpose *i.e.*, to the same, a little more or less, required for Storm Water drain and Widening and Strengthening of Poonamallee – Kundrathur – Pallavaram Road from 2 lane to 6 lane, Essa Pallavaram Village, Pallavaram Taluk, Chengalpattu District.
