The Government of Tamil Nadu having been satisfied that the lands specified in the Schedule below to be acquired for the formation of Western By-pass Road in Tirunelveli District from NH 7 in Thalaiyuthu Village of Manur Taluk in Tirunelveli District, and it having already been decided that the amount of compensation to be awarded for the lands are to be paid out of the funds controlled or managed by Divisional Engineer Highways Department.
