NOTICE UNDER SECTION 15(1) OF TAMIL NADU HIGHWAYS ACT, 2001 READ WITH THE TAMIL NADU LAND ACQUISITION LAWS (REVIVAL OF OPERATION, AMENDMENT AND VALIDATION) ACT, 2019

The Government of Tamil Nadu having been satisfied that the lands specified in the Schedule below to be acquired for the formation of Western By-pass Road in Tirunelveli District from NH-7 in Tharuvai Village of Palayamkottai Taluk in Tirunelveli District, and it having already been decided that the amount of compensation to be awarded for the lands are to be paid out of the funds controlled or managed by Divisional Engineer Highways Department. The following notice is issued under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002).

NOTICE

Under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002), the Governor of Tamil Nadu hereby acquires the lands specified in the Schedule below measuring an extent of 77595 Sq.mtrs to the same, a little more or less needed for the formation of Western By-pass Road in Tirunelveli District from NH 7 in Tharuvai Village of Palayamkottai Taluk in Tirunelveli District.
