The Government of Tamil Nadu has been satisfied that the lands specified in the Schedule below have to be acquired for industrial purposes, for the expansion of **Mine-IA-Neyveli Lignite Corporation India Limited** and it having already been decided that the entire amount of compensation to be awarded for the lands are to be paid out of the funds managed by the **Neyveli Lignite Corporation India Limited**.
