No. II(2)/LE/143/2009.—இந்த ஆணையின் இணைப்பில் குறிப்பிட்டுள்ள பொருள் தொடர்பாக அரசு விரைவு போக்குவரத்துக் கழகம், திருச்சி என்ற நிர்வாகத்துக்கும், அரசு விரைவு போக்குவரத்து ஊழியர் சங்கம், சி.ஐ.டி.யு., திருச்சி கிளைக்குமிடையே தொழிற்தகராறு எழுந்துள்ளது என்று அரசு கருதுவதாலும்;

மேற்சொன்ன தகராறை நீதிமன்றத் தீாப்புக்காக அனுப்புவது அவசியமென்று தமிழ்நாடு ஆளுநா் அவா்கள் கருதுவதாலும்;

1947ஆம் ஆண்டு தொழில் தகராறுகள் சட்டத்தின் (மத்திய சட்டம் XIV/1947) 10(1)(c) பிரிவிலும், 10(1)(d) பிரிவின் வரம்பு நிபந்தனையிலும் வழங்கியுள்ள அதிகாரங்களைக் கொண்டு தமிழ்நாடு ஆளுநர் அவர்கள் மேற்சொன்ன தகராறு திருச்சிராப்பள்ளி தொழிலாளர் நீதிமன்றத் தீர்ப்புக்காக அனுப்பப்பட வேண்டும் என்று இதனால் அணையிடப்படுகிறது.
