

Exemption in respect of tax payable by any dealer on the sale of clay for manufacture of bricks under the Tamil Nadu Value Added Tax Act.

I. VESTING OF PROPERTIES

Whereas, an application has been made to the Government of Tamil Nadu under clause (b) of sub-section (1) of Section 6 of the Charitable Endowments Act, 1890 (Central Act VI of 1890) by Dr. J. Ranganathan, residing at New No. 14 (Old No. 81), Venkataratnam Nagar, Adyar, Chennai-600 020, the donor of the said Endowment for vesting the property specified in the Schedule below, in the Treasurer of Charitable Endowments, Chennai, appointed under Section 3 of the said Act for the State of Tamil Nadu, the Governor of Tamil Nadu, in exercise of the powers conferred by Section 4 of the said Act, hereby orders that the said property be vested in the Treasurer aforesaid, and be held by him and his successors in office, subject to the provisions of the said Act and the rules which from time to time, may be or shall be made or deemed to have been made there under and subject to the conditions setforth in the Scheme settled under Section 5 of the said Act, for the administration of the said Endowment.

II. SCHEME FOR ADMINISTRATION

Whereas, an application has been made to the Government of Tamil Nadu under clause (b) of sub-section (1) of Section 6 of the Charitable Endowments Act, 1890 (Central Act VI of 1890) by Dr. J. Ranganathan, New No. 14 (Old No. 81), Venkataratnam Nagar, Adyar, Chennai-600 020, the donor of the said Endowment specified above, for settling a scheme for administration of the said Endowment, the Governor of Tamil Nadu, in exercise of the Powers conferred by sub-section (1) of Section 5 of the Charitable Endowments Act, 1890 (Central Act VI of 1890), hereby settles the scheme setforth in the Schedule below for the administration of the said Endowment and appoints the Principal, Presidency College (A), Chennai to administer the property. The scheme shall come into operation from the date of publication of this Notification in the Tamil Nadu Government Gazette.

THE SCHEDULE

1. The fund shall be called "**Dr. J. Ranganathan Charitable Endowment Fund**" tenable in the Presidency College (Autonomous), Chennai-600 005.

2. From and out of the annual interest accuring on the Fund the meritorious student of third year under graduate course in Statistics subject (excluding English and language subjects) who secures the highest mark in Theory and Practical Examinations will be given books and a certificate as prize.

3. The conduct and character of the student should be good and no punishment on disciplinary grounds should have been received by the student during his/her course of study in the college to receive the prize.

4. Any other prize or award received by the student will not be a disqualification to receive the prize.

5. The prize may be in the form of books and certificate and shall be from and out of 50% of annual interest accruing on the amount endowed. The remaining 50% of annual interest shall be utilized for the purpose of conducting endowment Lecture in the Department of Statistics every year.

6. If in any year, the prize could not be awarded the interest accrued will be added to the corpus of the Fund.

7. The Principal, Presidency College (Autonomous), Chennai will be the authority operating the fund, in consultation with the College council and decide the recipient of the award based on the marks, performance and conduct of the awardee and on the recommendation of the Head of the Department of Statistics.

8. The amount of the said Fund shall be invested from time to time and re-invested in Government Securities.

9. The decision of the Aministrator shall be final in all matters relating to the administration of the said Fund.
