Amendment to Special Rules for the Tamil Nadu Medical Service.

Errata to Notifications

[G.O. (D) No. 337, Health and Family Welfare (AA 2), 20th March 2009, Panguni 7, Thiruvalluvar Aandu-2040.]

The following Errata are issued to the G.O.Ms. No. 363, Health and Family Welfare (AA 2), 3rd October 2007:—

ERRATA

- (i) For the expressions viz appointment for Male and Female Nurses "occurring in the Abstract of the G.O., the expression viz" "appointment from Male and Female Nurses" shall be substituted.
- (ii) For the expressions, "Nursing Tutor II Grade for Female and Male Nurses" occurring in paras 2 and 3 of the Order, the Expressions "Nursing Tutor II Grade for Female and Male Nurses" shall be substituted.

PERSONNEL AND ADMINISTRATIVE REFORMS DEPARTMENT

Amendments to Tamil Nadu Government Servants' Conduct Rules, 1973.

[G.O. Ms. No. 38, Personnel and Administrative Reforms (A), 3rd April 2009, Panguni 21, Thiruvalluvar Aandu-2040.]

No. SRO B-25/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Government Servant's Conduct Rules, 1973.—

2. The amendment hereby made shall come into force on the 3rd April 2009.

AMENDMENTS

In the said Rules, for rule 10, the following rule shall be substituted namely:-

"10. Communication of official information.—Every Government servant shall, in performance of his duties in good faith, communicate information to a person in accordance with the Right to Information Act, 2005 (Central Act 22 of 2005) and the rules made thereunder:

Provided that no Government servant including the Government Pleaders, Public Prosecutors and other officials who are not full-time officers, but are engaged by the Government to do specified work without prejudice to the regular exercise of their professions in other respects shall, except in accordance with any general or special order of the Government or in performance in good faith of the duties assigned to him, communicate, directly or indirectly, any official document or any part thereof or classified information either in hard copy or in electronic format to any Government servant or any other person to whom he is not authorized to communicate such official document or classified information (including in electronic format):

Provided further that the above proviso shall not apply to the Special Public Prosecutors and Pleaders engaged to do Government work generally in specified local areas or specially in any particular case or class of cases".

SOCIAL WELFARE AND NUTRITIOUS MEAL PROGRAMME DEPARTMENT

Amendments to Tamil Nadu General Subordinate Service.

[G.O. Ms. No. 47, Social Welfare and Nutritious Meal Programme (SW-9), 23rd March 2009, Panguni 10, Thiruvalluvar Aandu-2040.]

No. SRO B-26/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules published with the Social Welfare Department Notification SRO B-231/86, dated the 18th April 1986 at pages 304-308 of Part III—Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 21st May 1986:—

2. The amendments hereby made shall come into force on the 23rd March 2009.

AMENDMENTS

In the said Rules,-

- (1) in rule 3, in the TABLE, for the entries in column (2) against the entry "Junior Rehabilitation Officer" in column (1) thereof, the following entries shall be substituted, namely:—
 - "(i) By direct recruitment; or
 - (ii) By promotion from the posts of-
 - (a) Vocational Instructor;
 - (b) Orthotic Technician; and
 - (c) Multipurpose Rehabilitation Aide:

Provided that appointment to the post by direct recruitment and by promotion shall be made in the ratio of 1:4

Provided further that appointment to the post by promotion from the posts of Vocational Instructor, Orthotic Technician and Multipurpose Rehabilitation Aide shall be made in the ratio 1:3:1";

- (2) in rule 4, for the expression "Joint Director of Social Welfare", the expression "State Commissioner for the Disabled" shall be substituted;
 - (3) in rule 5, sub rule (b),-
- (a) for the expression "No person shall be eligible for appointment by direct recruitment, to the post specified in column (1) of the Table below unless he possesses the educational qualifications specified in the corresponding entries in column (2) thereof", the following expression shall be substituted, namely:—

"No person shall be eligible for appointment to the posts specified in column (1) of the Table below by the method specified in column (2), unless he possesses the educational qualifications specified in the corresponding entries in column (3) thereof";

- (b) in the Table,—
- (i) a new column under the heading "Method of Appointment" shall be inserted as column (2) and the exisiting column (2) under the heading "Qualification" shall be renumbered as column (3);
- (ii) in column (2) as so inserted, against the entry "Junior Rehabilitation Officer" in column (1) and the entries "(i) Post Graduate degree in Psychology or Post Graduate degree in Social Work or Sociology; and

Not less than two years experience in administration and interpretation of Psychological tests; or in placement of the handicapped" in column (3) as so renumbered, the entry "(1) By direct recruitment" shall be inserted:

- (iii) against the entry "Junior Rehabilitation Officer" in column (1), after the entry "By direct recruitment" in column (2) as so inserted and the entries relating thereto in column (3) as so renumbered, the following entries shall, respectively, be inserted in columns (2) and (3) namely:—
 - "(2) By promotion from the Posts of Vocational Instructor, Orthotic Technician and Multipurpose Rehabilitation Aide.
- (i) Post Graduate degree in Psychology or Social Work or Sociology;
- (ii) Must possess experience for ten years as Orthotic Technicians/Vocational Instructor;
- (iii) Must possess experience for fifteen Years as Multipurpose Rehabilitation Aide in District Rehabilitation Centres of State Commissionerate for the Disabled Department.";

- (iv) in column (2) as so inserted,-
- (A) against the entry "2 Vocational Instructor" in column (1), the entry "By direct recruitment" shall be inserted in column (2) as so inserted,—
- (B) against the entry "3. Workshop Attendant" in column (1), the entry "By direct recruitment" shall be inserted in column (2) as so inserted.

YOUTH WELFARE AND SPORTS DEVELOPMENT DEPARTMENT

Amendments to Special Rules for Tamil Nadu General Subordinate Service.

[G.O. Ms. No. 20, Youth Welfare and Sports Development (YW), 23rd March 2009, பங்குனி 10, திருவள்ளுவர் ஆண்டு–2040.]

No. SRO B-27/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, and in supersession of the rules published with the Youth Welfare and Sports Development Department Notification No. 09, Published at pages 38-39 of Part III—Section 1(b) of the *Tamil Nadu Government Gazette*, dated 11th March 2009, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu General Subordinate Service (Section 13 in Volume III of the Tamil Nadu Services Manual, 1970).

2. The amendment hereby made shall be deemed to have come into force on the 1st August 1967.

AMENDMENTS

In the said Special Rules, in Class XLVI-EDUCATION DEPARTMENT:-

- 1. In rule 1, for the expression "Lascars and Drivers", the expression "Lascars, Drivers and Boat Lascars" shall be substituted.
- 2. In rule 2, in the Table, after the entry "Driver" in Column (1) and the corresponding entries in Column (2) thereof, the following entries shall, respectively, be added, namely:—

"Boat Lascar

- (1) by direct recruitment, or
- (2) by recruitment by transfer from the post of Peon in the National Cadet Crops Unit in the Tamil Nadu Basic Service, or
- (3) by transfer from the post of Lascar in the National Cadets Crops Unit", or
- 3. in rule 4, in the Table, in column (1), for the expression "Lascars" in Column 1, the following expression shall be substituted, namely:—

"Lascars and Boat Lascars".
