Vesting of Properties and Scheme for administration relating to Professor Dr. A. Jesudos and professor Dr. K. Balasubramanian Endowment Fund tenable by the Head of Department of ENT, Thanjavur Medical College, Thanjavur for conducting Endowment for awarding Gold Medals under Charitable Endowments Act.

No.II(2)/HF/197/2009.—In the matter of the Charitable Endowments Act, 1890 (Central Act VI of 1890) and in the matter of Endowment Fund for "Prof. Dr. A. Jesudos and Prof. Dr. K. Balasubramanian Endowment" for awarding Gold Medals for Under Graduate students of ENT in the Competitive Examination (Written and Orals) to be held every year fixed by the Head of Department of ENT, Thanjavur Medical College, Thanjavur.

I. VESTING OF PROPERTY.

Whereas an application has been made to the Government of Tamil Nadu under clause (b) of sub-section (i) of Section 6 of the Charitable Endowments Act, 1890 (Central Act VI of 1890) by Prof. Dr. A. Jesudos and Prof. Dr. K. Balasubramanian, the donor of the Endowment Fund specified above for vesting Rs. 25,000/- (Rupees twenty five thousand only) in the Treasurer of Charitable Endowments appointed under the said Act, for the State of Tamil Nadu. The Governor of Tamil Nadu in exercise of the powers conferred by section 4 of the said Act, hereby directs, that the said amount be vested in the Treasurer aforesaid and be held by him and his successors in office, subject to the provisions of the said Act and to any rules, which, from time to time, may be or shall be deemed to have been made thereunder, upon trust for the purpose and subject to the

conditions set-forth in the scheme settled under section 5 of the said Act for the administration of the said Fund.

II. SCHEME FOR ADMINISTRATION

Whereas an application has been made to the Government of Tamil Nadu under clause (b) of sub section (i) of Section 6 of the Charitable Endowments Act, 1890 (Central Act VI of 1890) by Prof. Dr. A. Jesudos and Prof. Dr. K. Balasubramanian, Thanjavur Medical College, Thanjavur, the donor of the Endowment Fund Specified above, for settling the Scheme for the administration of the said Fund. The Governor of Tamil Nadu in exercise of the powers conferred by section 5 of the said Act, hereby settles the Scheme set-forth in the schedule below for the administration of the said Fund and appointed from the date of publication of this Notification in the *Tamil Nadu Government Gazette*, as the date on which the Scheme as settled shall come into operation.

THE SCHEDULE:

- 1. The Endowment Fund shall be called as "Prof. Dr. A. Jesudos and Prof. Dr. K. Balasubramanian Endowment", The above Fund has to be settled for the purpose of awarding Gold Medals to the Under Graduate Students of ENT in the Competitive Examinaton (Written and Orals) to be held every year fixed by the Head of Department of ENT, Thanjavur Medical College, Thanjavur.
- 2. The Thanjavur Medical College, emblem shall be embossed on the obverse side and the insignia / words "Prof. Dr. A. Jesudos and Prof. Dr. K. Balasubramanian, Medal for ENT-UnderGraduate" shall be affixed on the reverse side of the Gold Medal.
- 3. The Dean, Thanjavur Medical College, Thanjavur shall be the administrator of the Fund and shall deposit the amount furnished by the Donor Prof. Dr. A. Jesudos and Prof. Dr. K. Balasubramanian with the Treasurer of Charitable Endowments, Government of Tamil Nadu, Chennai-2 who will from time to time invest or reinvest the amount and proceeds in Government securities to the best interest of the Fund.
- 4. The interest accrued annually shall be utilised for purchase of Gold Medals every year and it shall be given to the best students annually on the college day.
- 5. As and when there is need for more funds to conduct this examination, funds will be contributed by the donor or any one of his family members to conduct this examination periodically every year.
- 6. The unutilised amount accrued as into rests shall be added to the corpus of the Fund.
- 7. The best students shall be selected by the adjudicating Committee comprising the following Members:—
- (i) Professor and Head of Department of ENT, Thanjavur Medical College, Thanjavur.
- (ii) Additional Professors of Department of ENT, Thanjavur Medical College, Thanjavur.
