Amendments to Special Rules for Tamil Nadu General Subordinate Service

[G.O.Ms.No.103, Higher Education (F2), 18th May 2009, Vaikasi 4, Thiruvalluvar Aandu-2040.]

No. SRO B-34/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu General Subordinate Service.

2. The amendments hereby made shall be deemed to have come into force on the 1st January 1986.

AMENDMENTS

In the said Special Rules, in Class XIV,-

- (1) in rule 1, under the heading "Category," the expression "Graduate Librarians" shall be omitted;
- (2) in rule 2,-
 - (i) in sub-rule (a), in the tabular column, the entry "1. Graduate Librarian" in first column and the corresponding entries in second column shall be omitted;
 - (ii) in sub-rule (b), the figure "1" shall be omitted;
- (3) in rule 4, in the TABLE, for the entries "Graduate Librarians and Librarian" in column (1), the entry "Librarian" shall be substituted;
 - (4) in rule 6,—
 - (i) in sub-rule (a), in the TABLE, the entries, "Graduate Librarians in Government Colleges" in column (1) and the corresponding entries in column (2) thereof shall be omitted;
 - (ii) in sub-rule (b), in the TABLE, the entries, "Graduate Librarians in Government Colleges" in column (1) and the corresponding entries in column (2) thereof shall be omitted;
 - (5) in rule 7, in sub-rule (b), the expression "1. Graduate Librarians" shall be omitted;
 - (6) rule 8 shall be omitted.

Amendments to Special Rules for Tamil Nadu Collegiate Educational Service

[G.O.Ms.No. 104, Higher Education (F2), 18th May 2009, Vaikasi 4, Thiruvalluvar Aandu-2040.]

No.SRO B-35/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Collegiate Educational Service (Section 8-B in Volume II of the Tamil Nadu Services Manual, 1969).

The amendments hereby made shall be deemed to have come into force on the 1st January 1986.

AMENDMENTS

In the said Special Rules,-

(1) in rule 1, after Class VIII in column (1) and the corresponding entries in columns (2) and (3) thereof, the following Class and entries shall, respectively, be added, namely:—

"IX — College Librarian.";

(2) in rule 2, in sub-rule (a), after Class VIII in column (1) and the corresponding entries in column (2) thereof, the following Class and entries shall, respectively, be added, namely:—

"Class IX-

College Librarian Direct recruitment";

- (3) in rule 5, in sub-rule (a), in the Table, after item 4 in column (1) and the corresponding entries in column (2) thereof, the following item and entries shall, respectively, be added, namely:—
 - "5. College Librarian 35 Years.";
- (4) in rule 7, in sub-rule (b), for the expression "under Classes VI to VIII", the expression "under Classes VI to IX" shall be substituted;
 - (5) in rule 13, after the expression "on 26th March 2002", the following expression shall be added, namely:—
- "and the persons who have already been appointed and holding the post of College Librarian in Government Colleges on 18th May 2009.
- (6) in rule 11, for the expression "Classes VI, VII and VIII," the expression "Classes VI,VII, VIII and IX" shall be substituted.
- (7) in the ANNEXURE, after the post "Director of Physical Education including Director of Physical Education in Law, Medical and Veterinary Colleges" in column (1) and the corresponding entries in columns (2) and (3) thereof, the following post and entries shall, respectively, be added, namely:—
 - "College Librarian in Direct Recruitment Government Colleges.
- (i) Master's Degree in Library Science or Information Science or Documentation or an equivalent Professional Degree with the minimum 55% of marks or its equivalent grade of B in the University Grants Commission seven point scale with a consistently good academic record, computerization of Library; and
- (ii) Pass in National Eligibility Test or State Level Eligibility Test or an accredited Test:

Provided that in the case of candidates belonging to Scheduled Castes or Scheduled Tribes and candidates with Ph.D., Degree who have passed Master's degree prior to the 19th September 1991, the minimum marks shall be 50%:

Provided further that candidates holding M.Phil or Ph.D., Degree as on 14th June 2006, need not pass National Eligibility Test or State Level Eligibility Test or an accredited Test."
