

#### Order: No. 111, Public (Special-A), 29th May 2009.

The Government have considered the recommendation of the High Court, Madras to depute Thiru M. Md. Jafarullah Khan, District Judge of the Tamil Nadu State Judicial Service functioning as Principal District Judge, Thanjavur to Puducherry Judicial Service for being posted as Chief Judge, Puducherry in the place of Thiru D. Krishnaraja, who has been ordered to be repatriated to his parent Department *viz.*, Tamil Nadu State Judicial Service.

2. The Government accordingly direct that Thiru M. Md. Jafarullah Khan, District Judge of Tamil Nadu State Judicial Service functioning as Principal District Judge, Thanjavur be deputed to the Puducherry Judicial Service for being posted as Chief Judge, Puducherry in the place of Thiru D. Krishnaraja, with effect from the date of assuming office as such.
