It is notified for information of the public that in connection with introduction of 25KV ac electric traction over the section of Newly converted BG Up line between Podanur Junction and Coimbatore Junction from location 485/1 (Ch: Km 485/43.00) to location 18/12A (Ch: Km 18/233.85) in Podanur-Coimbatore section of Salem Division of Southern Railway and Newly laid BG Up line between Coimbatore North and Irugur from location 14/23-23A (Ch: Km 14/331.90) to location 0/21 (Ch: Km 0/559.80) in Coimbatore-Irugur section of Salem Division of Southern Railway, height gauges have been erected at all the level crossings with clear height of 4.67m from road level with a view to prevent loads of excessive height from coming into contact or dangerous proximity to live traction wires.
