Draft Amendment to Tamil Nadu Motor Vehicles Rules, 1989.

[G.O. Ms. No. 554, Home (Tr. VII), 13th July 2009, ஆனி 29, திருவள்ளுவர் ஆண்டு–2040.]

No. SRO A-21/2009.—The following draft of an amendment to the Tamil Nadu Motor Vehicle Rules, 1989, which it is proposed to make in exercise of the powers conferred by Section 95 of the Motor Vehicle Act, 1988 (Central Act 59 of 1988) is hereby published for the information of all persons likely to be affected thereby, as required by sub-section (1) of Section 212 of the said Act.

2. Notice is hereby given that the draft amendment will be taken into consideration on or after the expiry of thirty days from the date of publication of this Notification in the *Tamil Nadu Government Gazette* and that any objection or suggestion, which may be received from any person with respect thereto before the expiry of the aforesaid period will be considered by the Government of Tamil Nadu.

3. Objection or suggestion, if any, should be addressed in duplicate to the Principal Secretary to Government, Home Department, Chennai-600 009.

Draft Amendment

In the said Rules, in rule 3, in clause (i), for the expression "120 kilometres", the expression "80 kilometres" shall be substituted.

EXPLANATORY NOTE

At present the minimum route length for Stage Carriage for "Express Service" is prescribed as 120 kms. which is a drawback for providing "Express Service" by State Transport Corporations undertaking to all moffussil routes. In order to reduce the journey time considering the interest of travelling public and to cover all moffussil routes it is essential to reduce the minimum route length for Express Services as 80 kms. The proposed draft amendment will ensure lesser travel time to public and cover all moffussil routes.

HOME, PROHIBITION AND EXCISE DEPARTMENT

Amendment to Tamil Nadu Liquor (Supply by Wholesale) Rules, 1983.

No. SRO A-22/2009.—In exercise of the powers conferred by Sections 17-D and 54 of the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Liquor (Supply by Wholesale) Rules, 1983.

2. The amendment hereby made shall be deemed to have come into force on the 1st April 2008.

In the said Rules, in rule 15, in sub-rule (3), in item (i), for the expression "66.60", the expression "69.72" shall be substituted.
