Rescission of Ad-interim Order attaching of money and other properties of Thiruvalargal Sri Andal Finance and its Sister Concerns, Gudiyatham, Vellore District under Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act.

No.II(2)/HO/407/2009.

[Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997 (Tamil Nadu Act 44 of 1997)—Thiruvalargal Sri Andal Finance and its Sister Concerns, Gudiyatham, Vellore District— Default in return of Deposits by the Financial Establishment—Ad-interim order attaching of the money and other properties of the said Financial Establishment under Section 3—Order—Issued — Cancelled.]

The following Government Order is published:

- (4) Government Letter No. 35594/Cts.IIA/2006, dated 13th September 2006 and 23rd October 2008.
- (5) From the Inspector-General of Police, Economic Offences Wing-II, Chennai, even No. and Dated 21st May 2008 and 19th November 2008.

Order.-No. 451, Home (Pol.19), 9th June 2009.

The Government in its order first read above have issued orders attaching the properties of Thiruvalargal Sri Andal Finance and its Sister Concerns, Gudiyatham, Vellore District under Section 3 of the Tamil Nadu Protection of Interests of Depositors (in Financial Establishements) Act, 1997 for default in return of deposits made by the depositors after maturity.

2. The Inspector-General of Police, Economic Offences Wing-II, Chennai in his letter second read above has reported that the case against Sri Andal Finance and its Sister Concerns, Gudiyatham, Vellore District has been registered under Non-Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997 in the year 1995 i.e. prior to the enactment of Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997. In this regard the Government have issued orders for attachment of properties of the said Financial Establishment under Tamil Nadu Protection of Interests of Depositors (in Financial Establishements) Act, 1997 instead of authorization under Criminal Law Amendment Ordinance 1944 Act.

- 3. The Government Pleader, High Court, Chennai in his opinion has stated that the offence invoived in the present case is not an offence under the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997. It is an offence only under the provisions of Criminal Law Amendment Act, 1944. As such, the Government can also consider to withdraw the G.O.Ms. No. 1066, Home Department, dated 24th October 2001 and also to issue separate orders authorizing the Competent Authority *viz.*, Deputy Superintendent of Police, Economic Offences Wing to take appropriate action against Sri Andal Auto Finance and 3 Sister concerns in Vellore District which will be the only proper course of law.
- 4. The Government after careful examination decided to accept the proposal of the Inspector-General of Police, Economic Offences Wing-II, Chennai in para 2 above.
- 5. Accordingly in exercise of the powers conferred by Section 3 of the Tamil Nadu Protection of interests of Depositors (in Financial Establishments) Act, 1997 (Tamil nadu Act 44 of 1997), the Governor of Tamil Nadu hereby rescinds the ad-interim order of attachment issued in the Government Order first read above.
