Draft Notification regarding Revision of minimum rates of wages for employment in Leather Goods Manufactory under Minimum Wages Act.

[G.O. (2D) No. 54, Labour and Employment (J1), 8th June 2009.]

No. II(2)/LE/423/2009.—The following draft of a Notification which it is proposed to issue in exercise of the powers conferred by clause (b) of sub-section (1) of Section 3 and sub-section (2) of Section 5 of the Minimum Wages Act, 1948 (Central Act XI of 1948), is hereby published for information of all persons likely to be affected thereby, as required by clause (b) of sub-section (1) of Section 5 of the said Act.

2. Notice is hereby given that, the Draft Notification will be taken into consideration on or after the expiry of two months from the date of publication of this Notification in the *Tamil Nadu Government Gazette* and that any objection or suggestion, which may be received from any person with respect thereto, before the expiry of the aforesaid period of two months will be considered by the Government of Tamil Nadu. Objection or suggestion, if any, should be addressed to the Principal Secretary to Government, Labour and Employment Department, Secretariat, Chennai-600 009, through the Commissioner of Labour, Chennai-600 006.

Zone-A: All Corporations

Zone-B: All areas other than Corporations.

- (2) Dearness Allowance.—In addition to the minimum rates of basic wages fixed above, the employees shall be paid dearness allowance as indicated below:
- (i) The Dearness Allowance, is linked to the Average Consumer Price Index of Chennai City for the year 2000 that is, 475 points (with base 1982=100) and for every rise of one point over and above 475 points, an increase of Rs. 3.95 (Rupees three and paise ninety five only) per month shall be paid as Dearness Allowance.
- (ii) The Dearness Allowance shall be caculated every month based on the availability of latest Consumer Price Index points.
- (3) When the nature of work is the same, no distinction in the payment of wages shall be made between men and women employees.

- (4) To arrive at daily rates of wages, the monthly wages shall be divided by 26.
- (5) Wherever the existing wages are higher than the minimum wages fixed herein, the existing wages shall be continued to be paid.

Order of detention of certain person and direct to appear before certain Official under Conservation of Foreign Exchange and Prevention of Smuggling Activities Act.

No. II(2)/PUSC/424/2009.—Whereas an order had been made by the Government of Tamil Nadu in G.O.SR.I/331-4/2009, Public (SC) Department, dated 12th June 2009 under section 3(1)(i) of the Conservation of Foreign Exchange and Prevention of Smuggling Activities Act, 1974 (Central Act 52 of 1974), directing that Thiru R. Viswanathan, son of Rangasamy, No. 550, Thandal Khazani, Puzhal Post, Chennai-600 066 be detained:

And, Whereas, the said Thiru R. Viswanathan, son of Rangasamy, No. 550, Tandal Khazani, Puzhal Post, Chennai-600 066 cannot be found;

And, Whereas, the Government of Tamil Nadu have reasons to believe that the said Thiru R. Viswanathan, son of Rangasamy, No. 550, Thandal Khazani, Puzhal Post, Chennai-600 066, to appear before the Commisioner of Police, Chennai Sub-urban Police, St. Thomas Mount, Chennai-600 016, at his office within a period of 15 days (fifteen days) from the date of publication of this order in the *Tamil Nadu Government Gazette*.
