**Appointment of Presiding Judge of the Designated Court under the Terrorist and Disruptive Activities (Prevention) Act.****Amendment to Notification.**

[G.O. Ms. No. 678, Home (Courts II), 18th August 2009.]

No. II(2)/HO/448/2009.—In exercise of the powers conferred by sub-section (4) of Section 9 of the Terrorist and Disruptive Activities (Prevention) Act, 1987 (Central Act 28 of 1987), the Governor of Tamil Nadu, with the concurrence of the Chief Justice, High Court, Madras makes the following amendment to the Home Department Notification No. II(2)/HO/3929(b-2)/91, published at page 1 of Part II-Section 2 of the *Tamil Nadu Government Gazette* Extraordinary, dated the 11th July 1991 as subsequently amended:—

## AMENDMENT

In the said Notification, for the expression “Thiru A. Sampath, I Additional City Civil and Sessions Judge, Chennai”, the following expression shall be substituted, namely:—

“Thiru P. Ramalingam, I Additional City Civil and Sessions Judge, Chennai.”

**Notifications under Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act.****Ad-interim order attaching of the Share Certificate and other ancestral properties due to default in return of deposits by certain Financial Establishments under the Act.****Thiruvallur B.S.R. Group of Companies, Madurai.**

[G.O. Ms. No. 337, Home (Police-XIX), 24th April 2009.]

No. II(2)/HO/449/2009.—Whereas, complaints have been received from a number of depositors that Tvl. B.S.R. Group of Companies, Madurai a Financial Establishment has defaulted the return of deposits made by the depositors after maturity;

2. And, whereas, the Government are satisfied that the said Financial Establishment is not likely to return the deposits to the depositors and hence, the Government have to protect the interests of such depositors;

3. And, Whereas, the ancestral property and the Share Certificates specified in the Schedule I and Schedule-II respectively to this Order are alleged to have been owned by the partners of the said Financial Establishment.

4. Now, therefore, in exercise of the powers conferred by Section 3 of the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997 (Tamil Nadu Act 44 of 1997), the Governor of Tamil Nadu hereby

makes an ad-interim order attaching the Share Certificates of Tvl. Venkatachalam and Mahadevan and ancestral property of Tvl. Mahadevan, Venkatachalam, Nagarajan and Kannan, all are sons of A.V. Sankararaman, Partners of BSR Group of Companies, Madurai, as specified in the Schedule-I and Schedule-II respectively to this Order and transfers the control over the said Share Certificates (672) and other immovable property to the Competent Authority, namely, the District Revenue Officer, Madurai, appointed under the provisions of the said Act, for the purpose;

5. The Competent Authority is requested to pursue further action in accordance with the procedures laid down in sub-sections (3) and (4) of Section 4 of the said Act and also the formalities prescribed in the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Rules, 1997.

6. The Special Public Prosecutor, Special Court for the Tamil Nadu Protection of Interests of Depositors (in Financial Establishments) Act, 1997 is requested to render necessary assistance to the Competent Authority, in filing the application, before the said Special Court.
