Amendment to Tamil Nadu Standards of Weights and Measures (Enforcement) Rules, 1989.

[G.O. 2(D) No. 75, Labour and Employment (G1), 10th August 2009.]

No. SRO A-29/2009.—In exercise of the powers conferred by sub-sections (1) and (2) of Section 72 of the Standards of Weights and Measures (Enforcement) Act, 1985 (Central Act 54 of 1985), the Governor of Tamil Nadu, after consultation with the Central Government, hereby makes the following amendment to the Tamil Nadu Standards of Weights and Measures (Enforcement) Rules, 1989, the draft of the same having been previously published as required under sub-section (4) of Section 72 of the said Act.

2. The amendment hereby made shall come into force with effect on and from the date of publication of this Notification in the *Tamil Nadu Government Gazette*.

AMENDMENT

In the said Rules, in Schedule XII, under the heading "1. Weights", after the sub-heading "(e) Carat Weights" and the entries thereunder, the following sub-heading and entries shall be inserted, namely:—

"(f) Standard weights for testing of high capacity weighing machines:-
