Explanations.— (1) *Dearness Allowance.*— In addition to the minimum rates of basic wages as fixed above, the employees shall be paid dearness allowance as indicated below:—

(i) The dearness allowance is linked to the Average Chennai City Consumer Price Index for the year, 2000 That is, 475 points and for every rise of one point over and above 475 points, an increase of Rs. 6.00 per month (Rupees six only) shall be paid as dearness allowance.

(ii) The dearness allowance shall thus be calculated every year on the 1st April on the basis of the average of the Consumer Price Index for the preceding twelve months that is from January to December.
