In the Government Order first read above, orders were issued instituting the 'Kalpana Chawla Award' for Courage and Daring Enterprise by a woman who is a native of Tamil Nadu. In the Government Order second read above, orders were issued indicating the rules and guidelines to be followed for the selection of the Kalpana Chawla Awardee for Courage and Daring Enterprise. The Award shall be in the form of a Medal and named as "The Kalpana Chawla Award for Courage and Daring Enterprise". The medal shall be made of silver with gold coating and the cost of the medal shall be Rs.5,000/-. In addition to the medal, a cash certificate for Rs.5/- lakhs (Rupees Five lakhs only) will also be given. The medal will be presented by the Hon'ble Chief Minister of Tamil Nadu on the Independence Day.

2. In the Government Order third read above, the Government have re-constituted the Selection Committee. A list of women fit for nomination to the said award were called for from District Collectors and all Heads of Department and Registrars of all Universities under the aegis of Higher Education Department and Commissioner of Police, Chennai and Director General of Police, Tamil Nadu. An Advertisement was issued in the press inviting names of women who have performed courageous and daring acts.

3. After careful consideration of the recommendation of the Selection Committee, the Government have selected the following persons to receive the "Kalpana Chawla Award 2009" and to be felicitated by the Hon'ble Chief Minister of Tamil Nadu on the Independence Day Celebrations to be held on 15th August 2009:—

- Dr. N. Rajamaheswari, Professor and Heads of the Department, Department of Urogynaecology, Govt. Kasturba Gandhi Hospital, Triplicane, Chennai-5.
- (ii) Dr. Pushpanchali, No. 2, 5th Street, Teachers Colony, Thirukazhikkundram, Kancheepuram District.
- (iii) Selvi M. Rajalakshmi,
 D/o. Thiru R. Raju, No. 9-9-139,
 Avadi Thanga Nadar Street,
 Usilampatti-625 532.

4. In the letter read above, among other things Rs.5,10,000/- have been alloted under the head of account "2075.00.Miscellaneous General Services-800-Other expenditure-I Non Plan. HZ.Kalpana Chawla Award for Courage and Daring Enterprises-59. Prizes and Awards" (DPC 2075 00 800 HZ 5901). The amount allotted above is not sufficient to meet out the expenditure incurred towards the conferment of Kalpana Chawla Award since Hon'ble Chief Minister has ordered to confer the award for three persons for this year, instead of one person as awarded earlier.

5. Hence, in the G.O. fifth read above, an additional amount of Rs.10,80,000/- (Rupees ten lakhs and eighty thousand only) has been provided under the relevant head of account over and above the pending provision of funds in RE/FMA 2009-2010 towards the cost of medal, advertisement charges and cash award for Kalpana Chawla Award for Courage and Daring Enterprises. Now, the total amount of Rs.15,90,000/- are available to meet the expenditure.

6. Accordingly, Government sanction a sum of Rs.15,00,000/- (Rupees fifteen lakhs only) towards the cash award for the three Kalpana Chawla Awardees (Rs.5,00,000/- each) for the year 2009.

7. The expenditure shall be debited to "2075-00 Miscellaneous General Services-800-other Expenditure -I. Non Plan-HZ -Kalpana Chawla Award for Courage and Daring Enterprise—59 Prizes and Awards" (DPC 2075 00 800 HZ 5901).

8. The amount sanctioned in paragraph 6 above shall be drawn by the Section Officer, Public (Bills-A) Department and paid by means of three cheques at Rs.5,00,000/- (Rupees five lakhs only) each in favour of the awardees mentioned in para. 3 above.
