# Amendments to Ad hoc Rules relating to Temporary post of Tractor Cleaner for Tamil Nadu Agricultural Engineering Subordinate Service.

[G.O. Ms. No. 230, Agriculture (AA3), 20th October 2009]

No. SRO B-71/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Ad hoc Rules published with the Agriculture Department Notification No. 80 of 1950, dated the 28th April 1950 at page 1252 of Part 1 of the *Fort St. George Gazette*, dated the 9th May 1950:—

- 1. The amendment 1(a) (5); hereby made shall be deemed to have come into force on 17-9-69.
- 2. The amendments 2(b); 6(a); 6(c); 6(e); shall be deemed to have come into force on 9-11-77.
- 3. The amendments 2(a); 6(b); 6(d); 6(f); 6(g); shall be deemed to have come into force on 1-2-81.
- 4. The amendments 3; 4(2); 7; shall be deemed to have come into force on 25-7-86.
- 5. The amendments 1(b); shall be deemed to have come into force on 8-1-90.
- 6. The amendments 2(c); 4(1); shall come into force on 20th October 2009.

#### **AMENDMENTS**

- (1) In the said Rules, in Rule 1,-
  - (a) for the expression "Cleaners of tractors, Lorries and Jeeps" the expression "Cleaners" shall be substituted;
- (b) for the expression category 6 of the "Madras Inferior Service" the expression "Tamil Nadu Agricultural Engineering Subordinate Service" shall be substituted;
  - (2) In Rule 2,—
    - (a) the expressions "District Agricultural Officer concerned," or, and "as the case may be" shall be omitted;
- (b) for the expression "the Assistant Agricultural Engineer" the expression "the Assistant Executive Engineer (Agricultural Engineering)" shall be substituted;
- (c) for the expression "the Assistant Executive Engineer (Agricultural Engineering)" the expression "Executive Engineer (Agriculture Engineering)" shall be substituted.
- (3) In Rule 3, after the expression "Direct Recruitment" the expression "or by recruitment by transfer from the post of Mazdoor in Tamil Nadu Basic Service in Agricultural Engineering Department," shall be added;.
  - (4) for Rule 4, the following rule shall be substituted, namely:-
- "4 No person shall be eligible for appointment to the post by the methods specified in column (1) of the Table below, unless the possess the qualifications specified in column (2) thereof:—

(1) By direct recruitment

- (i) Must have passed VIII Standard.
- (ii) Must possess good physique.
- (iii) Must possess general knowledge of work connected with cleaning; greasing and oiling any Machinery, and
- (iv) Must possess a license to drive light Motor Vehicle issued by a competent authority.
- (2) By recruitment by transfer (i) Must have passed VI standard and should know to read;
  - (ii) Must possess good physique and knowledge of Agricultural machinery and possess aptitude and interest in handling Agricultural Machinery, and
  - (iii) Must have been appointed through the "Employment Exchange".

- (5) for Rule 5, the following rule shall be substituted namely:-
- "5 there shall be paid to the holders of the post of cleaners a pay calculated in the scale of pay 50-1-60 per month or any other scale as may be ordered from time to time".
  - (6) in Rule 6,-
- (a) in sub-rule (a),—for the expression "Joint Director of Agriculture" the expression "Superintending Engineer (Agricultural Engineering)" shall be substituted;
- (b) for the expression "Superintending Engineer (Agricultural Engineering)" the expression "Executive Engineer (Agricultural Engineering)" shall be substituted;
- (c) in sub Rule (b), in item (i), for the expression "Joint Director of Agriculture" the expression "Superintending Engineer (Agricultural Engineering)" shall be substituted;
- (d) for the expression "Superintending Engineer (Agricultural Engineering)" the expression "Executive Engineer (Agricultural Engineering)" shall be substituted;
- (e) in sub Rule (b), in item (ii),—for the expression "Joint Director of Agriculture" the expression "Superintending Engineer (Agricultural Engineering)" shall be substituted;
- (f) for the expression "Superintending Engineer (Agricultural Engineering), the Director of Agriculture", the expressions "Executive Engineer (Agricultural Engineering), Chief Engineer (Agricultural Engineering)" shall be respectively be substituted;
- (g) in sub Rule (c), for the expression "Regional Deputy Director of Agriculture" the expression "Executive Engineer (Agricultural Engineering)" shall be substituted.
  - (7) after Rule 6, the following rule shall be added, namely:-
- "7 Probation:—Every person appointed to the post by direct recruitment shall, from the date on which he joins duty be on probation for a total period of two years on duty with in a continuous period of three years.

"Provided that every person appointed to the post by recruitment by transfer shall, from the date on which he joins duty, be on probation for a period one year on duty within a continuous period of two years."

# Amendments to Ad hoc Rules relating to Temporary post of Junior Tractor Driver and Senior Tractor Driver for Tamil Nadu Agricultural Subordinate Service.

- No. SRO B-72/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Rules published with the Agriculture Department Notification No. 79 of 1950, dated the 28th April 1950 at pages 1251-1252 of Part 1 of the Fort St. George Gazette, dated the 9th May 1950:—
  - (1) The amendment 4 (a) hereby made shall be deemed to have come into force on the 12th December 1968.
  - (2) The amendments 1(b); 3(a); 4(f); 5(a); 6; shall be deemed to have come into force on the 2nd July 1974.
- (3) The amendments 4(c); 4(d); 7(a); 7(c); 7(g); shall be deemed to have come into force on the 9th November 1977.
- (4) The amendments 4(b); 4(e); 7(b); 7(d); 7(f); 7(h); shall be deemed to have come into force on the February 1st, 1981.

- (a) for the entry "Regional Deputy Director of Agriculture, concerned, after approval by the Joint Director of the Technical qualification possessed by the candidates" against the entries "3 Tractor drivers (Senior), 4 Tractor drivers (Junior), 5 Lorry drivers, and 6 Jeep drivers in column (1) the entry "Divisional Agricultural Engineer" shall be substituted;
- (b) for the entry "Regional Deputy Director of Agriculture concerned after approval of Superintending Engineer (Agricultural Engineering) of the technical qualifications possessed by the candidate" against the post "(7) Engine and Pumpsets drivers" in column (1), the entry "Executive Engineer (Agricultural Engineering)" shall be substituted;
- (c) for the entry "Divisional Agricultural Engineer" against the posts "(3) Tractor drivers (Senior), (4) Tractor drivers (Junior)" in column (1) the entry "Executive Engineer (Agricultural Engineering)" shall be substituted;
- (d) for the entry "Joint Director of Agriculture" against the posts "(1) Mechanics (Senior), (2) Mechanics (Junior) and (7) Engine and Pumpsets drivers" the entry "Superintending Engineer (Agricultural Engineering)" shall be substituted;
- (e) for the entry "Superintending Engineer (Agricultural Engineering)" against the posts "(1) Mechanics (Senior)" and (2) "Mechanics (Junior)" in column (1) the entry "Executive Engineer (Agricultural Engineering)" shall be substituted;

Tractor Driver (Senior)

- (1) Must Possess a current license issued by a competent authority to drive transport vehicle.
- (2) Must have served as Tractor Driver (Junior) for a period of not less than two years.

Tractor Driver (Junior)

#### By Direct Recruitment

- (1) A pass in 8th Standard;
- (2) Must Possess a current license issued by a Competent Authority to drive Light Motor Vehicle;
- (3) Must have completed a period of one year after obtaining Light Vehicle License and should have good knowledge in the mechanism of tractor; and
- (4) Must have Strong physique.

## By Promotion from the post of Cleaner

- (1) Must Possess a current license issued by a Competent Authority to drive Light Motor Vehicle; and
- (2) Must have served as cleaner for a period of not less than two years;
- (6) in rule 6 in the Tabular column, the entries "(5) Lorry Driver" and, "(6) Jeep driver" in column and the corresponding entries against these posts in column (2) thereof shall be omitted;
  - (7) In rule 7,
- (a) in sub rule (a), for the expression "Joint Director of Agriculture" the expression "Superintending Engineer (Agricultural Engineering)" shall be substituted;
- (b) in sub rule (a), for the expression "Superintending Engineer (Agricultural Engineering)", the expression "Executive Engineer (Agricultural Engineering)" shall be substituted;

- (c) in sub rule (b), in item (i) for the expression "Joint Director of Agricultural" the expression "Superintending Engineer (Agricultural Engineering)" shall be substituted;

No. SRO B-73/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules published with the Home Department Notification No. SRO B-38/2008, at pages 128 and 129 of Part III—Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 24th September 2008.

2. The amendments hereby made shall be deemed to have come into force on and from the 7th August 2008.

## **A**MENDMENTS

- (1) In Rules 1 and 3, the expression " and the Intelligence Section of the Office of the Commissioner of Police, Chennai" shall be omitted; and
  - (2) after rule 3, the following rule shall be inserted, namely:-

#### 3-A. Qualification:

No person shall be eligible for appointment to the post unless he is an approved probationer in the post of Senior Manager in the ministerial establishment of the State Intelligence Wing.

No. SRO B-74/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules published with the Home Department Notification No. SRO B-39/2008, at page 129 of Part III—Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 24th September 2008.

2. The amendments hereby made shall be deemed to have come into force on and from the 7th August 2008.

## **A**MENDMENTS

In the said Rule (1) in rules 1 and 3, the expression "and the Intelligence Section of the Office of the Commissioner of Police, Chennai" shall be omitted; and

(2) for rule 5, the following rule shall be substituted namely:-

#### 5. Qualification:

"No person shall be eligible for appointment to the post unless he has put in a service of not less than two years in the post of Manager in the State Intelligence Wing"; and

- (3) after rule 6, the following rule shall be inserted namely:-
- "6-A Probation.—(a) Every person appointed to the post shall be on probation for a total period of one year within a continuous period of two years.
- (b) The authority competent to declare the satisfactory completion of probation in one post shall be the Director General of Police, Tamil Nadu, Chennai provided no relaxation of rule is involved.
