Amendment to the Special Rules for the Tamil Nadu Medical Service.

[G.O.Ms.No. 368, Health and Family Welfare (AA1), 4th November 2009, Aippasi 18, Thiruvalluvar Aandu-2040.]

No. SRO B-82/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Medical Service (Section 21 in Volume II of the Tamil Nadu Services Manual, 1969).

2. The amendment hereby made shall be deemed to have come into force on the 1st October 1984.

AMENDMENT

In the said Special Rules, in Part II, under the heading "Branch III-Pharmacy", after rule 6, the following rule shall be added, namely:—

"7. Preparation of annual list of approved candidates.

For the purpose of drawing up of the annual list of approved candidates for appointment to the category, the crucial date on which the candidate should be qualified shall be the 15th March of every year.".

Amendments to the Tamil Nadu Government Servants' Conduct Rules, 1973.

[G.O. Ms. No. 158, Personnel and Administrative Reforms (A), 6th November 2009.]

No. SRO B-83/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Government Servants' Conduct Rules, 1973.

3. The amendments I and II hereby made shall be deemed to have come into force on the 9th September 2009.

AMENDMENTS

In the said Rules,

(1) in rule 2, in sub-rule (3), for Explanation (1) the following Explanation shall be substituted, namely:—

"Explanation (1):—The Government Servants holding posts in the Tamil Nadu State and Subordinate Services shall be classified as follows:—

Group-A: Government servants in posts drawing Grade pay of Rs. 6,600 and above.

Group-B: Government servants in posts drawing Grade pay of Rs. 4,400 and above but below Rs. 6,600

Group-C: Government servants in posts drawing Grade pay of Rs. 1,400 and above but below Rs. 4,400

Group-D: Government servants in posts drawing Grade pay of Rs. 1,300 .";

(2) In Schedule I, in Serial No. 3 the expression

"(i) in Non-Gazette rank" and "(ii) in Gazette rank" shall be deleted.

TAMIL DEVELOPMENT, RELIGIOUS ENDOWMENTS AND INFORMATION DEPARTMENT

Amendments to the Special Rules for the Tamil Nadu Hindu Religious and Charitable Endowments Administration Service.

[G.O.Ms.No. 335, Tamil Development, Religious Endowments and Information (RE 2-2), 9th November 2009, Aippasi 23, Thiruvalluvar Aandu-2040.]

No. SRO B-84/2009.—In exercise of the powers conferred by the provisio to Article 309 of the Constitution of India read with section 9 of the Tamil Nadu Hindu Religious and Charitable Endowments Act, 1959 (Tamil Nadu Act 22 of 1959), the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Hindu Religious and Charitable Endowments Administration Service (Section 18 in Volume II of the Tamil Nadu Services Manual, 1969):—

2. The amendments hereby made shall come into force on the 9th day of November 2009.

AMENDMENTS

In the said Special Rules, in rule 2-(i), in the Table under sub-rule (a), in column (3) against the entries "3. Assistant Commissioners including Additional Personal Assistant to the Commissioner" in column (1) and "(ii) By direct recruitment" in column (2) thereof,—

- (a) in item (ii),-
 - (a) the word "and" occurring at the end of the proviso shall be omitted;
 - (b) after the proviso, the following proviso shall be added, namely:-

"Provided further that the maximum age limit shall not apply in the case of a candidate in service, holding the post of Executive Officer Grade I or Grade II or Grade III or Grade IV', or Inspector or Head Clerk or Manager or Superintendent, in the Tamil Nadu Hindu Religious and Charitable Endowments Administration Department";

- (b) for item (iii), the following item shall be substituted, namely:-
 - "(iii) Must be actually practicing as an Advocate or as a Pleader in a Court of Civil or Criminal Jurisdiction for a period of not less than three years;

or

Must have put in a service of not less than six years in the post of Executive Officer, Grade I or Grade II or Grade IV, or Inspector or Head Clerk or Manager or Superintendent, in the Tamil Nadu Hindu Religious and Charitable Endowment Administration Department";

- (2) after sub-rule (e), the following sub-rule shall be added, namely:-
 - "(f) Notwithstanding anything contained in clause (14) of rule 2 in Part-I of the Tamil Nadu State and Subordinate Services Rules, persons who are in regular service in the post of Executive Officer Grade I or Grade II or Grade III or Grade IV, or Inspector or Head Clerk or Manager or Superintendent, in the Tamil Nadu Hindu Religious and Charitable Endowments Administration Department shall be eligible to be recruited direct to the post of Assistant Commissioner including Additional Personal Assistant to the Commissioner".
