No. SRO A-44/2009.—In exercise of the powers conferred by sub-section (1) of Section 138 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) read with sub-section (3) of Section 127 of the said Act, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Motor Vehicles Rules, 1989, the draft of the same having been previously published, as required by sub-section (1) of Section of 212 of the said Act:—

AMENDMENT

In the said Rules, after rule 382, the following rule shall be inserted, namely:-

"382-A. *Recovery of towing charges:*—The towing charges and helper charges which shall be recovered for removal of a motor vehicle, which is abandoned or left unattended on a public place or parked in a place where parking is legally prohibited, by towing service shall be as specified in the Table below:—
