Amendment to Notification under Tamil Nadu Prohibition Act

[G.O. Ms. No. 21, Home, Prohibition and Excise (III), 26th April 2010, Chithirai 13, Thiruvalluvar Aandu-2041.]

No. II(1)/HOPE/7/2010.—In exercise of the powers conferred by sub-section (1) of Section 18-B of the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937), the Governor of Tamil Nadu hereby makes the following amendment to the Prohibition and Excise Department Notification No. II(1)/PE/239(d)/81, published at page 2 of Part II—Section 1 of the *Tamil Nadu Government Gazette Extraordinary*, dated the 1st May 1981, as subsequently amended:—

In the said Notification, in the Annexure,

Declaration of the terminal of Indian Oil Corporation Limited at Mullakadu Part-I Village, Thoothukudi Taluk, Thoothukudi District as a "Prohibited Place" under the Official Secrets Act.

[G.O. No. SS.II/ 363-8/2009, Public (S.C.), 30th April 2010.]

No. II(1)/PUSC/8/2010.—Whereas, in the opinion of the Government of Tamil Nadu, it is necessary to declare the terminal of Indian Oil Corporation Limited at Mullakadu Part-I Village, Thoothukudi Taluk, Thoothukudi District as specified in the Schedule below to be a "Prohibited Place" under sub-clause (d) of clause (8) of Section 2 of the Official Secrets Act, 1923 (Central Act XIX of 1923), on the ground that information with respect thereto, or the destruction or obstruction thereof, or interference therewith, would be useful to an enemy;

And, whereas, in pursuance of clause (1) of Article 258 of the Constitution of India, the Government of India, Ministry of Home Affairs, have, in their Notification No. S.O. 1285, dated the 4th May 1963, published in the *Gazette of India*, dated the 11th May 1963, entrusted to the Government of Tamil Nadu the functions of the Central Government in relation to any matter specified in sub-clauses (c) and (d) of clause (8) of Section 2 of the Official Secrets Act, 1923 (Central Act XIX of 1923);

Now, therefore, in exercise of the powers conferred by sub-clause (d) of clause (8) of Section 2 of the Official Secrets Act, 1923 (Central Act XIX of 1923), the Governor of Tamil Nadu hereby declares, with effect on and from the date of publication of this Notification in the *Tamil Nadu Government Gazette*, the terminal of Indian Oil Corporation Limited at Mullakadu Part-I Village, Thoothukudi Taluk, Thoothukudi District as specified in the Schedule below, to be a "Prohibited Place" for the purposes of the said Act:—
