

From the Registrar General, High Court, Madras, D.O. Letter No. 15/2010-Con.B2, dated 21st April 2010.

#### ORDER: No. 108, Public (Special-A), 29th April 2010

Accepting the proposals of High Court sent by the Registrar General, High Court, Madras, the Government direct that Thiru T. Ramasamy, District Judge of the Tamil Nadu State Judicial Service functioning as Special Judge, Special Court under T.N.P.I.D. Act, Chennai, be deputed to the Puducherry Judicial Service for being posted as Judge, Family Court, Pondicherry in the place of Thiru V. Arumugam, who has been ordered to be repatriated to his parent department *viz.*, Tamil Nadu State Judicial Service and Thiru T. Mohandoss, District Judge of Tamil Nadu State Judicial Service, functioning as Presiding Officer, II Additional Labour Court, Chennai be deputed to the Puducherry Judicial Service for being posted as II Additional District Judge, Pondicherry in the place of Thiru E.M.K.S. Siddharthar, who has to be transferred and posted as III Additional District Judge, Pondicherry in the existing vacancy.

2. The Government also direct that Ms. R. Margaret Rosaline, District Judge of Puducherry Judicial Service functioning on deputation in Tamil Nadu State Judicial Service as Presiding Officer, Additional Labour Court, Vellore be repatriated to her parent department *viz.*, Puducherry Judicial Service for being posted as Additional District Judge, Karaikal *vice* Thiru D. Jayachandran.
