Constitution of a Special Safety Committee to prevent blast accidents in the Fire Crackers Factories.

No. II(2)/LE/29/2010.

[Committee-Constitution of a Special Safety Committee to prevent blast accidents in the Fire Crackers Factories-Orders-Issued.]

The following Government Order is published:-

READ:

From the Chief Inspector of Factories letter No. B1/3240/2007, dated 15-02-2007, 28-03-2007 and 14-07-2008.

ORDER: No. 79, Labour and Employment (M2), 30th June 2009.

On 24th January 2007 a blast occurred in a Cracker Factory at Sivakasi Taluk. To enquire into such incidents, the State Government, direct that a Special Safety Committee be constituted for providing safety measures to be followed and to prevent blast accidents in the Fire Crackers Factories in Virudhunagar District. The Government also appoint under Section 90(1) of the Factories Act, 1948, a Special Safety Committee comprising of the following members to enquire into the causes of the accidents and to prevent the blast accidents in the Fire Crackers Factories:—

- Additional Chief Inspector of Factories, Office of the Chief Inspector of Factories, Chepauk, Chennai-5.
- Thiru Bhojan, IOFS ... Member General Manager (Works), Tamil Nadu Industrial Explosives Ltd., Del Post, Vellore.
- Dr. P. Nagaraj, ... Member Lecturer and Department Head, Mechanical Engineering Division, MEPCO Schelink Engineering College, Sivakasi.
- 2. The above committee shall be treated as a first class committee for the purpose of Dearness Allowance and Travelling Allowance for the non-official members. The Additional Chief Inspector of Factories is entitled to sanction the Dearness Allowance and Travelling Allowances to the above non-official members and the expenditure will be debited under the following head of account:—

"2230-Labour and Employment-01-Labour-102-Working conditions and Safety-I-Non Plan-AB. Inspector of Factories-04-Travel Expenses 01-Tour Travelling Allowances".

- 3. The terms and conditions of the Special Safety Committee are as follows:—
- (i) All the Fire Crackers Factories in Virudhunagar District should be inspected and the harmful aspects, Chemical incompatibility and the disastrous effects caused from that should be observed.
- (ii) For this purpose, Risk analysis should be undertaken.

- (iii) According to schedule XXIV under Rule, 95 of the Tamil Nadu Factories Rules, 1950, it should be analysed whether all safety measurers are adhered to and if needed, additional safety guidelines should be recommended.
- (iv) According to Explosives Act, it should be analysed whether the rules are followed in the fire Cracker Factories.
- (v) The workers engaged in the production of crackers should be provided with sufficient awareness regarding the accidents. Awareness relating to Safety and Protection should be offered to them.
- (vi) In order to avoid blast accidents, certain alternative arrangements should be recommended.
- 4. The above committee should submit their full-fledged report to the Government within two months, from the date of issue of this order.
- 5. The Chief Inspector of Factories shall send necessary proposals to Finance Department for inclusion of this expenditure in RE/FMA for 2009-10 at the appropriate stage.
- 6. This order issues with the concurrence of the Finance Department *vide* its U.O. No. 35635/L&E/09, dated 24th June 2009.

No. II(2)/LE/31/2010.—In exercise of the powers conferred by sub-section (1) of Section 85 of the Factories Act, 1948 (Central Act LXIII of 1948), the Governor of Tamil Nadu hereby makes the following amendment to the Labour Department Notification No. II(2)/LAB/4650/88, dated the 13th June, 1988, published at page 617 of Part II—Section 2 of the *Tamil Nadu Government Gazette*, dated the 24th August 1988, as subsequently amended.

AMENDMENT

In the said Notification, after item 14, the following item shall be added, namely:—

"15. Any manufactory, in which any hazardous process, as defined under clause (cb) of Section 2 of the Factories Act, 1948 (Central Act LXIII of 1948) is carried on with or without the aid of power in the manufacturing process, other than those indicated above. In addition to the above Sections, Sections 41-A to 41-H of the said Act and the corresponding rules made thereunder shall also apply to such manufactories."
