### HEALTH AND FAMILY WELFARE DEPARTMENT

#### Amendments to the Special Rules for the Tamil Nadu Medical Service

*[G.O. Ms. No. 233, Health and Family Welfare (R2), 16th August 2010, Aadi 31, Thiruvalluvar Aandu-2041.]*

No.SRO B-70/2010—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Medical Service (Section 21 in Volume II of the Tamil Nadu Services Manual, 1969).

The amendments shall come into force on the Sixteenth August, 2010.

#### AMENDMENTS

In the said Special Rules, in Part-II, under the heading “Branch I-Medical”—

(1) in rule 3, in sub-rule (a), under Class XV, for the entries in column (2) against the expression “Mass Education and Information Officer” in column (1) thereof, the following entries shall be substituted, namely:—

“(1) By promotion from among the holders of the post of Maternal and Child Health Officer (Family Welfare), attached to the District Family Welfare Bureaux in the Tamil Nadu Medical Service; and

(2) By recruitment by transfer from among the holders of the post of District Extension Educator in the Tamil Nadu Medical Subordinate Service:

Provided that appointment to the post by promotion and by recruitment by transfer, shall be made in the ratio of 1:4.”;

(2) in the Annexure, referred to in rule 8 (c) under ‘Class XV’, for the entries in columns (1) and (2), the following entries shall, respectively, be substituted, namely:—

“Mass Education and Information Officer	.. (i) Must have served for a period of not less than five years in the post of Maternal and Child Health Officer (Family Welfare) for appointment by promotion.  (ii) Must have served for a period of not less than two years in the Post of District Extension Educator for appointment by recruitment by transfer.”

#### Amendments to Ad hoc rules relating to post of Public Health Nurse under Family Welfare Department

*[G.O. Ms. No. 234, Health and Family Welfare (R2), 16th August 2010, Aadi 31, Thiruvalluvar Aandu-2041.]*

No. SRO B-71/2010—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules published with the Health and Family Welfare Department Notification No. SRO-B.24/85, at pages 31-32 of Part III-Section 1 (b) of the *Tamil Nadu Government Gazette*, dated the 23rd January 1985, as subsequently amended.

2. (i) Amendment (1) hereby made shall be deemed to have come into force on the 31st January 2006.

(ii) Amendment (2) hereby made shall come into force on the 16th August, 2010.

## AMENDMENTS

In the said Rules

(1) in rule 1, for the expression "Public Health Nurse", the expression "Maternal and Child Health Officer (Family Welfare)" shall be substituted;

(2) for rule 3, the following rule shall be substituted, namely—

"3. *Appointment.*—Appointment to the post shall be made in the ratio of 2:1, in the substantive vacancies, as follows:—

(i) by direct recruitment; and

(ii) by recruitment by transfer from among the holders of the post of Staff Nurse in the Tamil Nadu Medical Subordinate Service".

No. SRO B-72/2010—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu General Subordinate Service (Section 13 of Part III-B of the Service Rules in Volume III of the Tamil Nadu Service Manual, 1954).

The amendments hereby made shall be deemed to have come into force with effect on and from the 25th October 1999.

## AMENDMENTS

In the said Special Rules,

(1) in Part-I the entry "Class LXV- Judicial Department" shall be omitted; and

(2) in Part-II, the heading "Class LXV-Judicial Department" and the rules there under shall be omitted.

**Ad hoc rules relating to temporary post of system Analyst for the Tamil Nadu Town Panchayats Department**

[G.O. Ms. No.180, Municipal Administration and Water Supply (TP.1), 25th August 2010.]

No. SRO B-73/2010.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:—

2. The Rules hereby made shall be deemed to have come into force on the 17th November 2000.

## RULES

The General and the Special rules applicable to the holders of the permanent post of Divisional Development Officer in category 3 of the Tamil Nadu Panchayat Development Service shall apply to the holders of the temporary post of System Analyst sanctioned from time to time for the Town Panchayats Department, subject to the modifications specified in the following rules:—

2. *Constitution.*—The post shall constitute a separate category in the said service.

3. *Appointment.*—(a) Appointment to the post shall be made as follows:—

(i) by direct recruitment; or

(ii) by recruitment by transfer from the post of Assistant Programmer in Tamil Nadu Town Panchayats Subordinate Service.

(b) Appointment to the post by recruitment by transfer shall be made on grounds of merit and ability, seniority being considered only where merit and ability are approximately equal.

4. *Qualifications.*—(a) *Age.*—No person shall be eligible for appointment to the post by direct recruitment, if he has completed or will complete the age of thirty five years on the first day of July of the year in which the selection for appointment is made.

(b) *Other qualification.*—No person shall be eligible for appointment to the post by the method specified in column (1) of the Table below, unless he possesses the qualifications specified in the corresponding entries in column (2) thereof:—

THE TABLE

<i>Methods of appointment (1)</i>	<i>Qualification (2)</i>
By direct recruitment	.. (1) (a) A Master Degree in Computer Science or a Master Degree in Computer Application; or  (b) (i) Bachelor Degree in Computer Science, (ii) Three years experience in Programming; and  (2) Adequate knowledge in Tamil.
By recruitment by transfer	.. Must have put in a service of not less than ten years as Assistant Programmer in Town Panchayats Subordinate Service.

5. *Probation.*—Every person appointed to the post by direct recruitment shall from the date which he joins duty be on probation for a total period of two years on duty within a continuous period of three years.

6. *Appointing Authority.*—Appointing authority for the post shall be the Director of Town Panchayats.

7. *Tests.*—Every person appointed to the post by direct recruitment shall within the period of his probation, pass the following tests namely,

- (1) Constitution of India and Miscellaneous Act;
- (2) Tamil Nadu District Municipalities Act, 1920;
- (3) Account Test for Subordinate Officers Part-I;
- (4) Tamil Nadu Government Office Manual:

Provided that the person who has already appointed to the post and commenced his probation before the issue of these rules for which the test qualification has been prescribed in these rules, should pass the test within a period of two years from the date of issue to these rules. Failure to pass the test within the above period will entail stoppage of increment until he passes the tests. However, the stoppage of increment will not have the effect of postponing his future increments after he passed the tests.

8. *Pay.*—There shall be paid to the holder of the post a monthly pay calculated in the scale of Rs. 8,000-275-13,500:

Provided that with effect on and from 01-01-2006, the monthly pay shall be calculated in the scale of Rs. 15,600 - 39,100 + 5,400 Grade Pay.

**Ad hoc rules relating to temporary post of Assistant Programmer for the Tamil Nadu Town Panchayats Department***[G.O. Ms. No.180, Municipal Administration and Water Supply (TP.1), 25th August 2010.]*

No. SRO B-74/2010.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:—

2. The Rules hereby made shall be deemed to have come into force on the 17th November 2000.

**RULES.**

The General and the Special rules applicable to the holders of the permanent post of Deputy Block Development Officer in category 2 of the Tamil Nadu Panchayat Development Subordinate Service shall apply to the holders of the temporary post of Assistant Programmer sanctioned from time to time for the Town Panchayats Department, subject to the modification specified in the following rules:—

2. *Constitution.*—The post shall constitute a separate category in the said class of the said service.

3. *Appointment.*—Appointment to the post shall be made as follows:—

(i) by direct recruitment; or

(ii) by transfer from any other category.

4. *Qualifications.*—(a) *Age.*—No person shall be eligible for appointment to the posts by direct recruitment, if he has completed or will complete the age of thirty five years on the first day of July of the year in which the selection for appointment is made.

(b) *Other qualification.*—No person shall be eligible for appointment to the post by the method of recruitment specified in column (1) of the Table below, unless he possesses the qualification specified in the corresponding entries in column (2) thereof:—

5. *Probation.*—Every person appointed to the post by direct recruitment shall from the date which he joins duty be on probation for a total period of two years on duty within a continuous period of three years.

6. *Appointing Authority.*—Appointing authority to the post shall be the Director of Town Panchayats.

7. *Tests.*—Every person appointed to the post by direct recruitment shall within the period of his probation, pass the following tests namely,

- (1) Constitution of India and Miscellaneous Act;
- (2) Tamil Nadu District Municipalities Act, 1920;
- (3) Account Test for Sub ordinate Officers Part-I;
- (4) Tamil Nadu Government Office Manual:

Provided that the person who has already appointed to the post and commenced his probation before the issue of these rules for which the test qualification has been prescribed in these rules, should pass the test within a period of two years from the date of issue of these rules. Failure to pass the test within the above period will entail stoppage of increment until he passes the tests. However, the stoppage of increment will not have the effect of postponing his future increments after he passed the tests.

8. *Pay.*—There shall be paid to the holder of the post a monthly pay calculated in the scale of Rs. 5,500-175-9,000:

Provided that with effect on and from 1st January 2006, the monthly pay shall be calculated in the scale of Rs. 9,300 - 34,800 + 4,400 Grade Pay.

#### **Amendments to Ad hoc Rules relating to post of Senior Lecturers in Directorate of Teacher Education, Research and Training and in District Institutes of Education and Training**

No. SRO B-75/2010.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the rules published in School Education Department Notification SRO No. B- 40/2007, at pages 60-63 of Part III-Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 11th July 2007.

2. The amendments hereby made shall come into force on and from the 7th September 2010.

#### AMENDMENTS

In the said Rules, in rule 5, in sub-rule (b), in the Table, in column (3) against the entry “Senior Lecturers in Directorate of Teacher Education, Research and Training and in District Institutes of Education and Training” in column (1) thereof,-

(i) against the entry “Direct recruitment” in column (2) thereof, after entry (ii), the following entry and proviso shall be added, namely:—

(iii) Teaching experience for a period of not less than five years as,—

(a) Lecturer in the Directorate of Teacher Education, Research and Training in the State of Tamil Nadu; or

(b) Lecturer in the District Institutes of Education and Training in the State of Tamil Nadu; or

(c) Approved Lecturer in any recognised Aided (or) Self-Financing Teacher Training Institute in the State of Tamil Nadu; or

(d) Junior Lecturer in a Government Teacher Training Institute in the State of Tamil Nadu:

Provided that nothing contained in these rules shall adversely affect the persons who have been recruited and appointed through the Teachers Recruitment Board's Notification No.2/2006-2007, dated the 19th August 2006.” ;

(2) against the entry “Promotion and recruitment by transfer” in column (2) thereof, for entry (iii), the following entry shall be substituted, namely:—

“(iii) Teaching experience for a period of not less than five years as Principal in any Government Teacher Training Institute or as Lecturer in the Directorate of Teacher Education, Research and Training or in the District Institutes of Education and Training.”.

1. தமிழ்நாடு பொதுப் பணியின் கீழடங்கும் பணியிடங்களில் நிரந்தர பதவி வகிப்போர்களுக்குப் பொருந்தும் பொது விதிகள் செந்தமிழ்ச் சொற்பிறப்பியல் அகரமுதலி திட்ட இயக்ககத்தில் தற்காலிக உதவி இயக்குநர் பணியிடத்தில் பணியாற்றி வருபவருக்கு, பின்வரும் விதிகளில் குறிப்பிட்டுள்ள மாற்றங்களுக்குட்பட்டு, பொருந்தும்.

2. பணியிட அமைப்பு.—இப்பணியிடமானது மேற்குறிப்பிட்டுள்ள பணியின் தனியொரு வகையினமாயிருக்கும்.

3. பணி நியமனம்.—இப்பணியிடத்திற்கு பின்வரும் முறைகளில் பணியமர்த்தம் செய்யப் பெறலாம்—

4. தகுதிகள்.—

**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules.

2. The rules hereby made shall be deemed to have come into force on the 20th December 2007.

**RULES**

The General Rules applicable to the holders of the permanent posts in the Tamil Nadu General Service shall apply to the holder of the temporary post of Assistant Director in the Directorate of Tamil Etymological Dictionary Project, Chennai, subject to the modification specified in the following rules:—

2. *Constitution.*—The post shall constitute a separate class in the said service.

3. *Appointment.*—Appointment to the post shall be made by recruitment by transfer from the post of Superintendent in the Directorate of Tamil Etymological Dictionary Project.

4. *Qualification.*—No person shall be eligible for appointment to the post unless he possess the following qualification:—

(a) Must possess a degree from any University recognized by the University Grants Commission with Tamil as one of the Part; and

(b) Must have not less than ten years of service in the post of Superintendent.

5. *Probation.*—Every person appointed to the post by recruitment by transfer, from the date on which he joins duty, shall be on probation for a total period of one year on duty within a continuous period of two years.

6. *Tests.*—Every person appointed to the post by recruitment by transfer shall pass the Account Test for Executive Officers within two years from the date of joining duty, failing which, the increment shall be withheld without cumulative effect.

Provided that every person appointed to the post has already passed the Account Test for Subordinate Officers, Part I and Part II, passing in Account Test for Executive Officer, shall not be necessary.

7. *Pay.*—There shall be paid to the holders of the post a monthly pay calculated in the Scale of Rs. 15,600-39,100 P.B. Grade Pay Rs. 5,400/-
