Explanations:—

(1) Dearness Allowance:—The employees shall be paid dearness allowance as indicated below:

(i) The wages notified above are linked to the Average Chennai City Consumer Price Index Number for the year 2000 (that is 475 points with base 1982=100) and for every rise of one point over above 475 points, an increase of 18 paise (eighteen paise only) per point per day shall be paid as dearness allowance.

(ii) The revision shall be effective from the 1st April of every year on the basis of the average indices for the earlier 12 months, that is, from January to December.

(iii) The first calculation shall, thus, be made effective, from the date of publication of this notification in the *Tamil Nadu Government Gazette* based on the average of Consumer Price Index for the previous year.

(2) Where the nature of work is same, no distinction in the payment of wages shall be made between men and women employees.

(3) The daily rate of wage and dearness allowance include the element of weekly holiday wages also.

(4) Wherever the existing wages are higher than the minimum rates of wages herein, the same existing wages shall be continued to be paid.

(ii) the Charge Officers to appoint within the local areas specified against them in the above Table, Supervisors and Enumerators, as and when directed by the Director of Census Operations, Tamil Nadu.

3. Under sub-section (1) of Section 6 of the Census Act, 1948 (Central Act XXXVII of 1948), the Governor of Tamil Nadu hereby appoints the Census Officers appointed in paragraph 1 above, for the purposes of the said sub-section (1) of Section 6 of the said Act.

4. Under Section 7 of the Census Act, 1948 (Central Act XXXVII of 1948), the Governor of Tamil Nadu hereby appoints the Census Officers appointed in paragraph 1 above, by written order, call upon the persons referred to in clauses (a) to (c) of the said Section 7 of the said Act within the local area over which he has jurisdiction to give such assistance for taking census of the persons in that local area.
