Amendments to the Adhoc Rules relating to the Technical Posts of Police Transport Workshop-*Cum*-Training School, Avadi and Regional Police Transport Workshop, Trichy in Police Department for the Public Service.

No. SRO B-97/2019.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Rules published with the Home Department Notification No.SRO B-217/85, dated the 4th May 1985, published at pages 229 to 251 of Part III—Section 1(b) of the Tamil Nadu Government Gazette, dated the 5th June 1985, as subsequently amended.

2. The amendments hereby made shall be deemed to have come into force with effect on and from the 1st June 1988.

AMENDMENTS.

In the said rules,-

- (1) in rule 3, in the TABLE, in column (2), against the entry "15.Chargeman" in column (1),-
- i) in item (i), for the expression "post of Tool Keeper and Fitter, Grade-II", the expression "post of Tool Keeper and Fitter, Grade-I" shall be substituted;
- ii) in item (ii), for the expression "Tool Keeper or Fitter, Grade-II", the expression "Tool Keeper or Fitter, Grade-III", the ex
 - (2) in rule 5, in sub-rule (b), in the TABLE, in column (4),-
- i) against the entries "11", "Fitter Grade- II" and "By recruitment by transfer from any other service" in columns (1), (2) and (3) respectively, for the expression "Helper", the expression "Fitter, Grade- II" shall be substituted;
- ii) against the entries "25", "chargeman" and "By promotion" in columns (1), (2) and (3) respectively for the expression "Must have put in service for not less than three years in the post of Tool Keeper or Fitter, Grade-II", the expression "Must have put in service for not less than three years in the post of Tool Keeper or Fitter, Grade-I" shall be substituted: and
- (3) In rule (9), after the expression "Police Transport Workshop-*Cum*-Training School, Avadi", the expression "or in the Regional Police Transport Workshop, Trichy", shall be inserted.
