(@) For this communal turns GT (PSTM) (NP) and BC (OTHER THAN BCM) (PSTM) (NP) the applicants who have studied in Tamil medium from Ist Standard to appropriate Technical Trade Certificate are eligible. No applicant had produced PSTM Certificate for Prescribed appropriate Technical Trade qualification. In The Tamil Nadu Appointment on Preferential Basis in the Services under the State of Persons Studied in Tamil Medium Act, 2010 (Act 40 of 2010) section 6, it is stated that where adequate number of qualified and suitable persons studied in Tamil medium are not available for appointment in the preferential vacancies shall be filled up with persons studied in other mediums within respective category. Hence applicant who has attended the interview and who has studied Technical qualification English Medium has been Provisionally selected based on marks scored in the interview.

(\$) In the communal turns GT(W)(NP), BC(OTHER THAN BCM)(W)(NP), MBC/DC(W)(NP) and SC(W)(NP) the women Applicants with prescribed qualification are eligible for selection. In this turn no qualified and suitable women Applicants are available. As per section 26(1) and Para 5 in Explanation of Tamil

Nadu Government servants (Conditions of Service) Act 2016, if No women Applicants are available in the particular turn allotted for women in the cycle, then the turn so allotted shall go to the male Applicant. Hence as per proviso, mentioned above in Tamil Nadu Government servants (Conditions of Service) Act 2016, the vacancies in the above turns is being filled up with male Applicants who had attended the interview and selected based on marks scored in the interview.

- (**) In the communal turns for BC(Other than BCM)(W)(PSTM)(NP) and MBC/DC(W)(PSTM)(NP) women Applicants with PSTM in Ist Standard to appropriate Technical Trade Certificate are eligible. No qualified BC (Other than BCM) and MBC/DC women Applicant with PSTM Certificate for Prescribed Technical qualification are available. As per proviso in Section 6 of Tamil Nadu Appointment on Preferential Basis in the Services under the State of Persons Studied in Tamil Medium Act, 2010 (Act 40 of 2010) and 26(1) of Act Tamil Nadu Government servants (Conditions of Service) Act 2016, the eligible male Applicants is selected against this turns BC (Other than BCM) (W)(PSTM)(NP) and MBC/DC(W)(PSTM)(NP).

Note : No eligible candidates in the communal turns BL_BCM (W) (DW)(NP), MBC/DC (Ex) (NP) and no eligible candidates claimed priority i.e. 1 to 20 as listed in the G.O.(Ms) No. 122, Human Resources Management (K.2) Department, Dated: 02.11.2021 in the communal turns GT (P), BC (OTHER THAN BCM) (P)–2 vacancies, MBC/DC (P) and ST (PSTM) (P) Hence the Selection has not been made under this turns and seven posts are kept vacant.
