##### ACQUISITION OF LANDS

[G.O. Ms. No. 70, Transport (I.1), 6th June 2011.]

#### No. II(2)/TRA/245(c-1)/2011.

Whereas, in exercise of the powers conferred by clause (1) of the Article 258 of the Constitution of India, the President of India, has, in the Ministry of Food, Agriculture, Community Development and Co-operation (Department of Agriculture) Notification No. 4(1)/65, General-II, dated the 23rd April 1966, entrusted to the Government of Tamil Nadu with their consent, the functions of the Central Government under the Land Acquisition Act, 1894 (Central Act I of 1894) in relation to the acquisition of lands for the purposes of the Union in this State;

And, whereas, the Lands specified in the Schedule below are needed for a public purpose to wit for provide approach Road due to the formation of Salem-Karur Broad Gauge Railway Line Project, notified to the effect is hereby given to all to whom it may concern in accordance with the provisions of sub-section (1) of Section 4 of the Land Acquisition Act, 1894 (Central Act I of 1894);

And, whereas, it has become necessary to acquire the immediate possession of the Lands specified in the Schedule below, the Governor of Tamil Nadu hereby directs that the Lands to be acquired under the provisions of sub-section (2) of Section 17 of the said Act;

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section 4 of the said Act, the Governor of Tamil Nadu hereby authorises the Special Tahsildar Land Acquisition, Unit-I, Salem-Karur Broad Gauge Railway Line Project, Namakkal and his staff and workmen to exercise the powers conferred by the said sub-section under clause (c) of Section 3 of the said Act, the Governor of Tamil Nadu hereby appoints the Special Tahsildar Land Acquisition, Salem - Karur Broad Gauge Railway Line Project, Namakkal to perform the functions of the Collector under the said Act.

Under sub-section (4) of Section 17 of the said Act, the Governor of Tamil Nadu hereby directs that, in view of the urgency of the case, the provisions of Section 5-A of the Act shall not apply to this case.

And, whereas, the land specified in the schedule below are needed for a public purpose to wit for formation of New Broad Gauge Railway Line between Tindivanam to Nagari by the Southern Railway, notice to that effect is hereby given to all to whom it may concern, in accordance with the provisions of sub-section (1) of Section 4 of the Land Acquisition Act, 1894 (Central Act I of 1894);

And, whereas, it has become necessary to acquire the immediate possession of the lands specified in the schedule below, the Governor of Tamil Nadu hereby directs that the Lands be acquired under the provision of sub-section (1) of Section 17 of the said Act.

Now, therefore, in exercise of the powers conferred by sub-section (2) of Section (4) of the said Act, the Governor of Tamil Nadu hereby authorises the Revenue Divisional Officer, Ranipet, Vellore District, his staff and workmen to exercise the powers conferred by the said sub-section.

Under sub-section (4) of Section 17 of the said Act, the Governor of Tamil Nadu hereby directs that in view of the urgency of the case, the provisions of Section 5-A of the said Act shall not apply to this case.
