AMENDMENTS TO THE CHENNAI METROPOLITAN AREA GROUNDWATER (REGULATION) RULES, 1988.

In exercise of the powers conferred by sub-section (1) of section 18 of the Chennai Metropolitan Area Groundwater (Regulation) Act, 1987 (Tamil Nadu Act 27 of 1987), the Governor of Tamil Nadu hereby makes the following amendments to the Chennai Metropolitan Area Groundwater (Regulation) Rules, 1988:-

AMENDMENTS.

In the said Rules.—

(1) in rule 4, in sub – rule (1), for the expression “Forms-II and III respectively”, the expression “Form-II” shall be substituted;

(2) for “FORM-II”, the following Form shall be substituted, namely:-

NOTE:-

- (1) Incomplete applications and applications not received in the prescribed form are liable to be summarily rejected.
 - (2) Court-Fee stamp for the value of Re.1 shall be affixed on each application.
 - (3) The consent of the owner of the source of water (if such owner is not the applicant) should invariably accompany the application.
 - (4) Licence will be issued, if approved by the competent authority within a period of 90 days from the date of receipt of the application, on payment of the prescribed fee.
 - (5) Separate licence should be obtained for each well and vehicle, as the case may be.”;
- (3) Form-III shall be omitted.
