DISQUALIFICATION OF 3RD WARD MEMBER, MUKKULAM SATHANUR VILLAGE PANCHAYAT, NEEDAMANGALAM PANCHAYAT UNION, TIRUVARUR DISTRICT UNDER TAMIL NADU PANCHAYATS ACT, 1994.

WHEREAS, the opinion of the Tamil Nadu State Election Commission was sought for, regarding the disqualification of Thiru.M.Praveenraj, Third Ward Member, Mukkulam Sathanur Village Panchayat, Needamangalam Panchayat Union, Tiruvarur District, as required under sub-section (2) of Section 41 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994) as he has absented himself from three consecutive meetings of the said Village Panchayat;

AND WHEREAS, the Tamil Nadu State Election Commission, after conducting an enquiry and verification of the relevant records and report furnished by the Village Administrative Officer, Mukkulam Sathanur, has confirmed that Thiru.M.Praveenraj, 3rd Ward Member of the said Village Panchayat, has not attended three consecutive meetings of the said Village Panchayat held on 15th July, 2022, 17th August, 2022 and 16th September, 2022 since he has gone to a foreign country due to his private affairs and opined that the said member is disqualified to continue as member of the said Mukkulam Sathanur Village Panchayat, under clause (i) of sub-section (3) of Section 38 of the said Act;

NOW THEREFORE, under sub-section (1) of section 41 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994), the Governor of Tamil Nadu hereby decides that Thiru.M.Praveenraj, 3rd Ward Member, Mukkulam Sathanur Village Panchayat, Needamangalam Panchayat Union, Tiruvarur District has become disqualified from holding the office of member of the said Mukkulam Sathanur Village Panchayat, under clause (i) of sub-section (3) of Section 38 of the said Act as he has absented himself from three consecutive meetings of the said Village Panchayat held on and after 15th July 2022.
