AD HOC RULES RELATING TO THE TEMPORARY POST OF DEPUTY DIRECTOR AND ASSISTANT  
DIRECTOR UNDER THE WELFARE OF DIFFERENTLY ABLED PERSONS DEPARTMENT

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and in supersession of the Adhoc Rules for the post of Technical officer published with Social Welfare and Nutritious Meal Programme Department Notification No. SRO B-67/2003 in pages 83 and 84 of Part III—Section 1 (b) of the *Tamil Nadu Government Gazette* dated the 25th of June 2003, the Governor of Tamil Nadu hereby makes the following rules.

2. The rules hereby made shall be deemed to have come into force on the 12th of July 2012.

**RULES**

The Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (Tamil Nadu Act 14 of 2016) and the Special Rules applicable to the holders of the permanent post in the Tamil Nadu General Service shall apply to the holders of the temporary posts of Deputy Director and Assistant Director sanctioned from time to time for the Welfare of Differently Abled Persons Department, subject to the modifications specified in the following rules.

2. **Constitution** – The posts shall constitute separate categories in a distinct class of the said service.
3. **Appointment** – Appointment to the posts specified in column (1) of the table below shall be made by the methods specified in the corresponding entries in column (2) thereof:-

Deputy Director	By promotion from among the holders of the post of Assistant Director.
Assistant Director	(1) By promotion from among the holders of the post of District Differently Abled Welfare Officer in the Welfare of Differently Abled Persons Department; (or)

<i>Posts</i>	<i>Method of appointment</i>

	(2) By deputation from among the holders of the post of Deputy Collector in the Tamil Nadu Civil Service: Provided that the post of Assistant Director dealing with Administration in the Directorate for Welfare of the Differently Abled alone may be filled up by deputation.

**4. Qualifications** – No person shall be eligible for appointment to the posts specified in column (2) of the table below, by the methods specified in the corresponding entries in column (3), unless he possesses the qualification specified in the corresponding entries in column (4) thereof:-

1	Deputy Director	By promotion	Must have rendered service for a period of not less than three years in the post of Assistant Director.
2	Assistant Director	By promotion	Must have rendered service for a period of not less than two years in the post of District Differently Abled Welfare Officer.

**5. Preparation of annual list of approved candidate** – (1) For the purpose of drawing up of annual list of approved candidates for appointment to the post of Deputy Director the crucial date on which the candidates should be qualified shall be the 1st April of every year.

(2) For the purpose of drawing up of annual list of approved candidates for appointment to the post of Assistant Director by promotion, the crucial date on which the candidates should be qualified shall be the 1st May of every year.

**6. Pay** – There shall be paid to the holders of the posts specified in column (1) of the table below, monthly pay calculated in the Pay Band specified in column (2) thereof:-

Deputy Director	Pay Band 3 of Rs.15600 – 39100 with Grade Pay of Rs.6600
Assistant Director	Pay Band 3 of Rs.15600 – 39100 with Grade Pay of Rs.5400

Provided that with effect on and from the 1st January 2016, the monthly pay shall be calculated in Level 25 – Rs.59300 – 217600 for the post of Deputy Director and Level 22 – Rs.56100 – 205700 for the post of Assistant Director under the Tamil Nadu Revised Pay Rules, 2017.

**7. Saving Clause** – Nothing contained in these rules shall adversely affect the holders of the posts on 15th of March 2024.
