NOTIFICATION BY THE ELECTION COMMISSION OF INDIA

APPOINTMENT OF DATES FOR VARIOUS STAGES OF BYE-ELECTION TO TAMIL NADU LEGISLATIVE ASSEMBLY FROM 75.VIKRAVANDI ASSEMBLY CONSTITUENCY AND FIXATION OF HOURS OF POLL TO FILL A VACANCY CAUSED BY THE DEATH OF A MEMBER

The following Notification of the Election Commission of India, Nirvachan Sadan, Ashoka Road, New Delhi-110 001, dated 14th June, 2024 [24 Jyaishtha, 1946 (Saka)] is published:

No. 100/TN-LA/2/2024:- **WHEREAS**, the seat of Thiru N. Pugazhenthi, in the Legislative Assembly of the Tamil Nadu State, elected from 75-Vikravandi Assembly Constituency in Villupuram District, has become vacant on 06-04-2024, by reason of death; **and**

- 2. WHEREAS, a bye-election is to be held for the purpose of filling the vacancy so caused; and
- 3. **NOW, THEREFORE,** in pursuance of sub-section (1) of section 150, and sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:-
 - (A) Calls upon the said 75-Vikravandi Assembly Constituency in the State of Tamil Nadu to elect, before the 15-07-2024 (Monday) and in accordance with the provisions of the said Act and of the rules and orders made there under, a person, for the purpose of filling the said vacancy in the Legislative Assembly of the State; and
 - (B) Appoints, with respect to the said election,-
 - (a) the 21-06-2024 (Friday), as the last date for making nominations;
 - (b) the 24-06-2024 (Monday), as the date for scrutiny of nominations;
 - (c) the 26-06-2024 (Wednesday), as the last date for withdrawal of candidatures;
 - (d) the 10-07-2024 (Wednesday), as the date, on which a poll shall, if necessary, be taken;
 - (e) the 15-07-2024 (Monday), as the date before which the election shall be completed, and

(C) Fixes the hours from 07:00 A.M. to 06:00 P.M. as the hours during which the poll shall, if necessary, be taken on the date specified above, for the election.
