DISQUALIFICATION OF 1ST WARD MEMBER, BETTAMUGULALAM VILLAGE PANCHAYAT, KELAMANGALAM PANCHAYAT UNION, KRISHNAGIRI DISTRICT UNDER THE TAMIL NADU PANCHAYATS ACT, 1994.

WHEREAS, the report of District Collector, Krishnagiri District stating that Thiru.V.Ranganathan, 1st Ward Member, Bettamugulalam Village Panchayat, Kelamangalam Panchayat Union, Krishnagiri District is to be disqualified under clause (i) of sub-section (3) of Section 38 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994) as he was absent himself for three consecutive meetings of the said Village Panchayat since December 2020 and he was arrested and imprisoned under Narcotic Drugs and Psychotropic Substances Act, 1985 (Central Act 61 of 1985);

AND WHEREAS, the opinion of the Tamil Nadu State Election Commission was sought for regarding the disqualification of Thiru.V.Ranganathan, 1st Ward Member, Bettamugulalam Village Panchayat, Kelamangalam Panchayat Union, Krishnagiri District as required under sub-section (2) of Section 41 of the said Act;

AND WHEREAS, the Tamil Nadu State Election Commission, after conducting an enquiry and verification of the relevant records has confirmed that Thiru.V.Ranganathan, 1st Ward Member of the said Village Panchayat, has not attended three consecutive meetings of the said village panchayat held on 05.12.2020, 04.01.2021 and 02.02.2021 since he has been arrested and imprisoned under Narcotic Drugs and Psychotropic Substances Act, 1985 (Central Act 61 of 1985) and opined that Thiru.V.Ranganathan, 1st Ward Member, Bettamugulalam Village Panchayat, Kelamangalam Panchayat Union, Krishnagiri District shall be disqualified to continue as member of the said Bettamugulalam Village Panchayat, under clause (i) of sub-section (3) of Section 38 of the said Act;
