REMOVAL OF CHAIRMAN AND VICE-CHAIRMAN OF LATHUR PANCHAYAT UNION COUNCIL,
CHENGALPATTU DISTRICT UNDER THE TAMIL NADU PANCHAYATS ACT, 1994.

WHEREAS, a written notice of the intention to make a motion expressing want of confidence in Tmt.B. Subalakshmi Babu, Chairman and Tmt.R. Krishnaveni Thanigachalam, Vice - Chairman, Lathur Panchayat Union Council, Chengalpattu district, signed by twelve members, out of the sanctioned strength of fifteen members of the said Council, together with a copy of the motion proposed to be made and a written statement of charges against the said Chairman and Vice - Chairman have been delivered to the Revenue Divisional Officer, Maduranthagam, Chengalpattu district in person by twelve members as per sub-section (2) of Section 212 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994);

AND WHEREAS, the Revenue Divisional Officer, Maduranthagam, Chengalpattu district caused a copy of the statement of charges along with a copy of the notice of motion to be delivered, to the said Chairman Tmt.B.Subalakshmi Babu and Vice - Chairman Tmt.R.Krishnaveni Thanigachalam and they submitted their reply to the charges;

AND WHEREAS, a motion expressing want of confidence in Tmt.B.Subalakshmi Babu, Chairman and Tmt.R.Krishnaveni Thanigachalam, Vice - Chairman, Lathur Panchayat Union Council, Chengalpattu district had been carried with a support of twelve members out of the sanctioned strength of fifteen members of the said Panchayat Union Council in the meeting convened by the Revenue Divisional Officer, Maduranthagam, Chengalpattu district on the 13th October 2023 after following the procedures specified in the said section 212 and forwarded the same to the Government;

NOW THEREFORE, in exercise of the powers conferred by sub-section (13) of Section 212 of the Tamil Nadu Panchayats Act, 1994 (Tamil Nadu Act 21 of 1994), the Governor of Tamil Nadu hereby removes Tmt.B.Subalakshmi Babu, Chairman, Lathur Panchayat Union Council, Chengalpattu district from the office of the Chairman of the said Panchayat Union Council and Tmt.R.Krishnaveni Thanigachalam, Vice - Chairman, Lathur Panchayat Union Council, Chengalpattu district from the office of the Vice - Chairman of the said Panchayat Union Council, with immediate effect.
