The Government of Tamil Nadu having been satisfied that the lands specified in the Schedule below are to be acquired for highways purpose to wit for the **Widening of SH-115 Cheyyur - Vandavasi - Polur Road (From 80/600 Km to 81/400 Km) under Chennai - Kanyakumari Industrial Corridor Project in 155. Chetpet-I (Addl.) Village, Chetpet Taluk, Tiruvannamalai District** and it having already been decided that the amount of compensation to be awarded for the lands are to be paid out of the funds controlled or managed by the Divisional Engineer, Vandavasi (CKICP), Tamil Nadu. The following notice is issued under sub-section (1) of Section 15 of the Tamil Nadu Highways Act, 2001 (Tamil Nadu Act 34 of 2002).
