Amendments to the Tamil Nadu Online Gambling Authority and Regulation of Online Games Rules, 2023

No. SRO A-10/2024.— In exercise of the powers conferred by sub-section (1) of Section 24 of the Tamil Nadu Prohibition of Online Gambling and Regulation of Online Games Act, 2022 (Tamil Nadu Act 9 of 2023), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Online Gaming Authority and Regulation of Online Games Rules, 2023:-

AMENDMENTS.

In the said Rules,-

(1) for rule 11, the following rule shall be substituted, namely:-

"11. Leave.- (1) The Chairperson of the Gaming Authority may avail leave under intimation to the Government.

(2) A Member of the Gaming Authority may avail leave with the permission of the Chairperson":

(2) In rule 13, for sub-rule (1), the following sub-rule shall be substituted, namely:-

"(1) The other terms and conditions of service of the Chairperson and Members of the Gaming Authority (not provided for in these rules) shall be as prescribed by the Government, from time to time."

Amendments to the Tamil Nadu Legislators' Pension Rules, 1977

No. SRO A-11/2024.—In exercise of the powers conferred by section 14 of the Tamil Nadu Payment of Salaries Act, 1951 (Tamil Nadu Act XX of 1951), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Legislators' Pension Rules, 1977:-

2. The amendments hereby made shall be deemed to have come into force on the 1st April, 2020.

AMENDMENTS.

In the said Rules,-

(1) in rule 6,-

(i) for the expression "by about the 25th of every month", the expression "on the last working day of every month" shall be substituted.;

(ii) the expression "The Bank shall furnish a receipt for the amount received by means of cheque" shall be omitted.;

(iii) in the proviso, for the expression, "credited to that Fund", the following expression shall be substituted, namely; - "credited to that Fund through Electronics Clearance System."

(2) in rule 9-D,-

(i) for the expression "by about the 25th of every month", the expression "on the last working day of every month" shall be substituted.;

(ii) the expression "The Bank shall furnish a receipt for the amount received by means cheque" shall be omitted.

(3) after rule 9-E, the following rule shall be inserted, namely:-

"9-F Death of Family pensioner: - In the event of the death of the Family pensioner the amount of Family pension due till the date of his death, including unpaid arrears, shall be paid to his legal heir."

(4) In the ANNEXURE, in Form V and Form XIII, for the expression, "Paid Cheque No", the expression "Paid by IFHRMS Reference No" shall be substituted.
