No. I/PUSP/33/2024.—The following Notification of the Election Commission of India, dated 8th November 2024 shall be re-published:-

“In exercise of the powers conferred by sub-section (1) of Section 13A of the Representation of the people Act, 1950 (43 of 1950), the Election Commission of India in consultation with the Government of Tamil Nadu hereby designates Ms. Archana Patnaik, IAS (TN:2002) as the Chief Electoral Officer for the State of Tamil Nadu with effect from the date she takes over charge and until further orders in place of Shri Satyabrata Sahoo, IAS.

2. Ms. Archana Patnaik shall cease to hold and hand over forthwith the charge of all or any charges of work under the Government of Tamil Nadu, which she may be holding before such assumption of office.

3. Ms. Archana Patnaik while function as the Chief Electoral Officer, Tamil Nadu shall not hold any additional charge whatsoever under the Government of Tamil Nadu

except that she should be designated Secretary to the Government in charge of Election Department in the State Secretariat.
