Exemption from operation of certain provision to produce not exceeding the monthly production capacity of Indian-made Foreign Spirits in respect of certain manufacturing units under Tamil Nadu Indian-made Foreign Spirits (Manufacture) Rules.

Exemption of the Tenkasi Neighbourhood Scheme for the Construction of thirty houses under the Act.

No.II(2)/HOU/511/2008.—In exercise of the powers conferred by Section 69 of the Tamil Nadu State Housing Board Act, 1961 (Tamil Nadu Act, XVII of 1961), the Governor of Tamil Nadu hereby exempts the Tenkasi Neighbourhood Scheme for the construction of thirty houses at a cost of Rs. 111.76 lakhs (Rupees One hundred and eleven lakhs and seventy six thousand only) submitted by the Managing Director, Tamil Nadu Housing Board from the provisions of Section 49 except clause (b) of sub-section (2) of that section of the said Act.

Sanction of the Tenkasi Neighbourhood Scheme for the Construction of thirty houses under the Act.

No.II(2)/HOU/513/2008.—In exercise of the powers conferred by Section 152 of the Tamil Nadu State Housing Act, 1961 (Tamil Nadu Act, XVII of 1961), the Governor of Tamil Nadu hereby declares that in the areas in respect of which the Tenkasi Neighbourhood Scheme for the construction of 30 houses at the cost of Rs. 111.76 lakhs (Rupees One hundred and eleven lakhs and seventy six thousand only) is in force and for the period during which the said scheme remains in force the powers and functions exercisable by the Commissioner, Tenkasi Municipality, Tirunelveli District under the Tamil Nadu District Municipalities Act, 1920, in respect of receiving plans, sanctioning plans, regulating the construction of buildings, laying of roads, underground drainage, water mains and electricity connections and providing all amenities to the owners of the buildings and all the powers connected therewith shall be exercised by the Managing Director of the Tamil Nadu Housing Board.

2. The license fees which are due to the Commissioner, Tenkasi Municipality, Tirunelveli District for approval of the building plans of the Tamil Nadu Housing Board and for the sub-division of lands etc., shall be remitted by the said

Board after preparation of detailed plans and submission of the same to the Commissioner, Tenkasi Municipality, Tirunelveli District for formal approval.

Exemption from certain rule of Development Control Rules for Chennai Metropolitan Area for Construction of Multi-storied buildings in Perumbakkam Village, Okkiam Thuraipakkam Village, Tambaram Taluk at Kancheepuram District under Tamil Nadu Town and Country Planning Act.

[G.O.Ms. No.183, *Housing and Urban Development (UDI)*, 19th August 2008.]

No.II(2)/HOU/514/2008:—In exercise of the powers conferred by Section 113 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu, hereby exempts the lands in S.Nos.479/2, 482 to 485, 508 to 511, 516 to 518, 523, 524/1, 524/2, 527, 528, 538, 539/2, 540/1pt, 541 to 544 and 546 in Perumbakkam Village, Tambaram Taluk, Kancheepuram district and the lands in S.Nos.403/2 to 403/7 in Okkiam Thuraipakkam Village, Tambaram Taluk, Kancheepuram District from the provisions of sub-rule (a) of Rule 17 of the Development Control Rules for Chennai Metropolitan Area read with rule (A) of Annexure-X to the said Rules for the construction of multistoried buildings under Jawaharlal Nehru National Urban Renewal Mission-Basic Service to Urban Poor Programme by the Tamil Nadu Slum Clearance Board.

LABOUR AND EMPLOYMENT DEPARTMENT

Direction regarding certain provision not apply to employees who engaged workers for running Motor Transport Vehicles in plantations under Motor Transport Workers Act, 1961 and Tamil Nadu Motor Transport Workers Rules, 1965.

[G.O.Ms.No. 112, *Labour and Employment (H1)*, 22nd September 2008.]

No. II(2)/LE/515/2008.—In exercise of powers conferred by clause (iii) of sub-section (2) of Section 38 of the Motor Transport Workers Act, 1961 (Central Act 27 of 1961), the Governor of Tamil Nadu hereby directs that the provisions of the said Act and the Tamil Nadu Motor Transport Workers' Rules, 1965 shall not apply to the class of employers who engage workers for running motor transport vehicles in any plantations, for a period of three years on and from the date of publication of this notification in the *Tamil Nadu Government Gazette*, subject to the following conditions, namely:—

- (1) the motor transport workers employed in the plantation industry should enjoy all the benefits under the Plantations Labour Act, 1951 (Central Act LXIX of 1951);
- (2) they should be paid overtime wages for the work done in excess of forty-eight hours a week; and
- (3) they should be supplied with one pair of semi closed chappal for every twelve months.
