

#### ORDER : No. 160, Public (Special-A), 6th November 2008.

The Government have considered the recommendation of the High Court of Madras to repatriate Thiru E.M.K.S. Siddharthar, District Judge of Puducherry Judicial Service, functioning on deputation in the Tamil Nadu State Judicial Service, as Sessions Judge, Mahalir Neethimandram, Madurai, to his parent department *viz.*, Puducherry Judicial Service for being posted in the Union Territory of Puducherry.

2. The Government accordingly direct that Thiru E.M.K.S. Siddharthar, District Judge of Puducherry Judicial Service functioning as Sessions Judge, Mahalir Neethimandram, Madurai be repatriated to his parent department, *viz.*, Puducherry Judicial Service for being posted in the Union Territory of Puducherry.
