**Order: No. 1329, Public (Special-B), 1st December 2008.**

Thiru Veerapandi S. Arumugam, Minister for Agriculture, has been hospitalised for treatment at Chennai and it will take some more time for him to resume normal work. In view of the above, under Clause (3) of Article 166 of the Constitution of India, the Governor of Tamil Nadu hereby directs that the subjects "Agriculture, Agricultural Engineering, Agro Service Co-operatives, Horticulture, Sugarcane Cess, Sugarcane Development and Wasteland Development" hitherto held by Thiru Veerapandi S. Arumugam, Minister for Agriculture, be temporarily allocated to Thiru K. N. Nehru, Minister for Transport in addition to the subjects now held by him.
