Kerosene (Restriction on Use and Fixation of Ceiling Price) Amendment Order, 2008.

[G.O. Ms. No. 15, Co-operation, Food and Consumer Protection (C2), 24th February 2009.]

No. II(1)/CFCP/9/2009.—The following order of the Gazette of India, Ministry of Petroleum and Natural Gas, New Delhi, the 31st December, 2008 is republished:—

G.S.R.2(E).—In exercise of the powers conferred by Section 3 of the Essential Commodities Act, 1955 (10 of 1955), the Central Government hereby makes the following order further to amend the Kerosene (Restriction on Use and Fixation of Ceiling Price) Order, 1993, namely:—

1. (1) This Order may be called the Kerosene (Restriction on Use and Fixation of Ceiling Price) Amendment Order, 2008.

(2) It shall come into force on the date of its publication in the Official Gazette.

2. In the Kerosene (Restriction on Use and Fixation of Ceiling Price) Order, 1993.

(1) In clause 2,—

(a) item (ga) shall be omitted;

(b) item (ka) shall be omitted;

(2) In clause 8A shall be omitted.

3. In clause 9, In sub-clause (a), the words “draw and test samples of the product with the aid of test kit to determine blending of marker in kerosene” shall be omitted.

Amendments to notification under Tamil Nadu Buildings (Lease and Rent Control) Act.

[G.O. Ms. No. 52, Housing and Urban Development (Bud. 2), 6th April 2009.]

No. II(1)/HOU/10/2009.—In exercise of the powers conferred by Clause (a) of sub-section (1) of Section 23 of the Tamil Nadu Buildings (Lease and Rent Control) Act, 1960 (Tamil Nadu Act 18 of 1960), the Governor of Tamil Nadu hereby makes the following amendments to the Home Department Notification II-1 No. 3006 (f) of 1973, published at page 3 of Part II—Section 1 of the *Tamil Nadu Government Gazette* Extraordinary, dated the 30th June 1973, as subsequently amended.

2. The amendments hereby made shall come into force with effect on and from the date on which the District Judge, Dharmapuri district assumes charge.

AMENDMENTS

In the said Notification, in the Table,—

(1) the entry “District Judge, Dharmapuri” in column (1) and the corresponding entry “Dharmapuri district” in column (2), thereof shall be omitted; and

(2) in column (2), against the entry “All Subordinate Judges within their respective jurisdictions” in column (1), after the words “Theni district”, the words “Dharmapuri district, Krishnagiri district” shall be added.
