### Amendments to Tamil Nadu State and Subordinate Services Rules.

[G.O. Ms. No. 229, Personnel and Administrative Reforms (S), 26th December 2008

No. SRO B-30/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the General Rules in Part II of the Tamil Nadu State and Subordinate Services Rules (Volume I of the Tamil Nadu Services Manual, 1987).

2. The amendments hereby made shall be deemed to have come into force on the 14th September 2007.

#### AMENDMENTS

In the said Rules, in rule 22, in clause (g),—

(1) for the expression, "the shortfall vacancies", the expression "such vacancies treating them as 'shortfall vacancies" shall be substituted;

(2) for the proviso, the following proviso shall be substituted

"Provided that reservation for women, physically handicapped and Ex-servicemen shall not apply to the said recruitment."

No. SRO B-31/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu State and Subordinate Services Rules (Volume I of the Tamil Nadu Services Manual, 1987).

2. The amendment hereby made shall be deemed to have come into force on the 26th August 2008.

#### AMENDMENT

In the said Rules, in Part II—General Rules, to rule 5, after the last proviso, the following proviso shall be added, namely:—

"Provided also that this rule shall not apply to a physically handicapped candidate."

No. SRO B-32/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu State and Subordinate Services Rules (in Volume I of the Tamil Nadu Services Manual, 1987).

2. The amendment hereby made shall be deemed to have come into force on the 7th January 2003.

#### AMENDMENT

In the said Rules, in Schedule II to Part I—PRELIMINARY, under the heading "PART B SCHEDULED TRIBES", in entry 7, for the word "taluk", the words "and Ambasamudram taluks" shall be substituted.
