## NOTIFICATIONS BY GOVERNMENT

### HEALTH AND FAMILY WELFARE DEPARTMENT

#### Amendments to Special Rules for Tamil Nadu Public Health Service.

*[G.O. Ms. No. 429, Health and Family Welfare (L2), 23rd December 2008, Margazhi 8, Thiruvalluvar Aandu-2039.]*

No. SRO B-1/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for Tamil Nadu Public Health Service (Section 24, in Volume - II of the Tamil Nadu Services Manual, 1969) :—

The Amendments hereby made shall come into force with effect on and from 23rd December 2008.

#### AMENDMENTS

In the said Special Rules,—

(1) In rule, under class I, under the heading “Category” for the category 7, the following shall be substituted:—

“7-Senior Entomologist / District Malaria Officer / District Entomologist / Lecturer in Medical Entomology / Entomologist / Biologist”.

(2) “The expression 'Senior Entomologist' wherever it occurs, shall be read as follows:—

“Senior Entomologist / District Malaria Officer / District Entomologist / Lecturer in Medical Entomology / Entomologist / Biologist.”

(3) In the Table under Rule 4, for the entry in item (1) in column (3) against the entry “Senior Entomologist” in column (1) “a) Recruitment by transfer” in column (2) thereof, the following entry shall be substituted:—

“Senior Entomologist / District Malaria Officer / District Entomologist / Lecturer in Medical Entomology / Entomologist / Biologist	Recruitment by transfer	(1) In the case of an Entomological Assistant in the Tamil Nadu Public Health Subordinate Service, he  (a) Must have put in service of not less than five years as Entomological Assistant; and  (b) Successful completion of Diploma in Public Health Entomology at the Institute of Vector Control and Zoo noses, Hosur.”

### SCHOOL EDUCATION DEPARTMENT

#### Amendments to Ad hoc Rules relating to Tamil Nadu Teacher Educational Service.

#### NOTIFICATION-I

*[G.O. Ms.No. 247, School Education (U2), 11th December 2008.]*

No. SRO B-2/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the ad hoc rules published with the School Education Department Notification No.SRO B-38/2007 at pages 58-59 of Part III-Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 11th July 2007.

2. The amendment hereby made shall be deemed to have come into force on the 14th June 2007.

## AMENDMENT

In the said Rules, in rule 4, after item (iii) and before the Explanation thereunder, the following proviso shall be inserted, namely:—

“Provided that the minimum marks specified in items (i) and (ii) shall not apply in respect of persons who are otherwise qualified for appointment to the post by the methods specified in rule 3 as on the 14th June 2007”.

## NOTIFICATION-II

[G.O.Ms.No. 247, School Education (U-2), 11th December 2008.]

No. SRO B-3/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the ad hoc rules published with the School Education Department Notification No. SRO B-39/2007, at pages 59-60 of Part III-Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 11th July 2007.

2. The amendment hereby made shall be deemed to have come into force on the 14th June 2007.

## AMENDMENT

In the said Rules, in rule 5, in the Table, after item (iii) in column (2),—

(1) against the entry “Deputy Director in the Directorate of Teacher Education Research and Training and Principals of District Institutes of Education and Training” in column (1), the following proviso shall be added, namely:—

“Provided that the minimum marks specified in items (i) and (ii) shall not apply in respect of persons who are otherwise qualified for appointment to the post by the methods specified in rule 3 as on the 14th June 2007”.

(2) against the entry “Principals of Government Teacher Training Institutes” in column (1), the following proviso shall be added, namely:—

“Provided that the minimum marks specified in items (i) and (ii) shall not apply in respect of persons who are otherwise qualified for appointment to the post by the methods specified in rule 3 as on the 14th June 2007”.

## NOTIFICATION -III

[G.O.Ms.No. 247, School Education (U-2), 11th December 2008.]

No. SRO B-4/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the ad hoc rules published with the School Education Department Notification No. SRO B-40/2007, at pages 60 -63 of Part III-Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 11th July 2007.

2. The amendment hereby made shall be deemed to have come into force on the 14th June 2007.

## AMENDMENT

In the said Rules, in rule 5, in sub-rule (b), in the Table, in column (3),—

(1) against the entry “promotion and recruitment by transfer” in column (2) and the entry “Senior Lecturers in Directorate of Teacher Education Research and Training and District Institutes of Education and Training” in column (1) thereof, after item (iii), the following proviso shall be added, namely:—

“Provided that the minimum marks specified in items (i) and (ii) shall not apply in respect of persons who are otherwise qualified for appointment to the post as on the 14th June 2007”.

(2) against the entry “Direct recruitment and recruitment by transfer” in column (2) and the entry “Lecturers in Directorate of Teacher Education Research and Training and District Institutes of Education and Training” in column (1), after item (ii), the following proviso shall be added, namely:—

“Provided that the minimum marks specified in items (i) and (ii) shall not apply in respect of persons who are otherwise qualified for appointment to the post by recruitment by transfer as on the 14th June 2007”.

## NOTIFICATION - IV

[G.O.Ms.No. 247, School Education (U-2), 11th December 2008.]

No. SRO B-5/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the adhoc rules published with the School Education Department Notification No.SRO B-41/2007 at pages 63-66 of Part III -Section 1(b) of the *Tamil Nadu Government Gazette*, dated the 11th July 2007.

2. The amendment hereby made shall be deemed to have come into force on the 14th June 2007.

## AMENDMENT

In the said Rules, in rule 5, in sub-rule (b) in column (2), against the entry "Junior Lecturer" in column (1) thereof, after item (ii), the following proviso shall be added namely :—

"Provided that the minimum marks specified in items (i) and (ii) shall not apply in respect of persons who are otherwise qualified for appointment to the post by promotion as on 14th June 2007".
