**Constitution of State Level Nodal Agency consisting of certain official as Chairman and Chief Executive Officers under the DPAP and IWDP Schemes.**

No.II(2)/AG/368/2009.

[Agriculture—DPAP and IWDP—New Common Guidelines—Issued by the Government of India—State Level Nodal Agency Constituted—Orders—Issued.]

The following Government Order is published.

**Order: No.109, Agriculture (DPAP), 29th June 2009.**

Drought Prone Areas Programme (DPAP) is being implemented in Tamil Nadu since 1992-93. Under DPAP, watershed development projects are sanctioned by Government of India. Presently this scheme is being implemented in 80 notified blocks of 17 districts. So far totally 1622 watershed projects have been sanctioned to Tamil Nadu.

2. Intergrated Wasteland Development Programme (IWDP) is being implemented in Tamil Nadu since 1993-94 in non DPAP blocks. At present this programme is being implemented in 96 blocks of 24 districts. So far totally 945 watershed projects have been sanctioned to Tamil Nadu.

3. At State level, Commissioner DPAP is monitoring the implementation of the above mentioned schemes. At district level, Project Officer, District Rural Development Agency is implementing the programmes with 100 supporting staff (Technical/Ministerial Staff). In 2007-08 the Government of India have stopped to sanction new projects and introduced the New common guidelines for watershed development projects. The ongoing DPAP & IWDP programmes will be ended on 2011. The Government of India insisted to implement common guidelines for watershed development programme from 2008-09 onwards.

4. For implementation of Government of India's New Common Guidelines to the DPAP & IWDP schemes as requested by NRAA, Government of India, a State Level Nodal Agency will be constituted and the Chairperson and Chief Executive Officer of State Level Nodal Agency will be nominated.

5. Accordingly the Executive Director, Tamil Nadu Watershed Development Agency (TAWDEVA), has sent a proposal to Government to constitute a State Level Nodal Agency. He has stated that the implementation of common guidelines will bring necessary convergence, co-ordination, networking and harmonization with the emerging policies, programmes and funding portfolio of different ministries. It is also informed that NWDPR scheme in the States will be implemented on the basis of these common guidelines with effect from 01-04-2008 and also requested to appoint the Chairperson and the Chief Executive Officer for the SLNA as per Para 24 of the guidelines. He has also stated that the appointment of Chairperson and Chief Executive Officer and other members shall be notified shortly.

6. The Executive Director, TAWDEVA has stated that the State Level Nodal Agency for Watershed Development Projects in the state may be constituted and necessary Government notification also be made at the earliest to avoid delay in getting Government of India funds for new watershed development projects from various ministries of Government of India to the State. The Technical Expert (Watershed Development), Ministry of Agriculture, NRAA, Government of India, New Delhi have informed that with reference to para 25 of Common Guidelines it was decided that the representative of State Forest Department should also be a member in the said State Level Nodal Agency. Therefore as requested by NRAA, Government of India, the State Level Nodal Agency having an independent Bank account, the appointment of Chairperson, Chief Executive Officer of State Level Nodal Agency and other Representatives as per para 22 to 28 of Common guidelines. He has also requested the Government to constitute State Level Nodal Agency to monitor the implementation of DPAP & IWDP with composition of following members:—
